



Leg banding Procedure courtesy of the NATIONAL FINCH SOCIETY



The most important thing to remember when you begin to band a finch is to do it over a counter or table in case the chick makes a sudden move, it will not fall to the floor.



The age of the bird to be banded varies with the species. Generally it will be between five and six days old. You can tell by looking at the ankle joint (the joint where the toes come together) and the size of the band.



The band is generally placed on the right leg of the bird. Banding just before the nightly roost will help prevent picking of the band by the parents. By the next morning the birds will have forgotten about the band.

Have the band ready with a toothpick (or other blunt instrument and a lubricant. Hold the chick firmly but in a way not to cut off the air supply or to burt the bird.



Put a little bit of lubricant on the bird's foot and slide the band over the front three toes and finally over the ankle joint. The back toe will probably have to be pried out from under the band with a toothpick. The band is now in the proper location between the ankle and elbow joints.



It is best to check on the chick after a few days to make sure the band has not slipped off. Before banding, make sure the band is right side up so that it can be easily read.

BREEDING THE BLUE-BLACK GRASSQUIT by Dr. Yal Clear

The Blue-black Grassquit, also called the Jacarini, from its Latin name, <u>Volatina jacarini</u>, is a small South American bird that has been bred on various occasions in aviaries, but I am not aware of anyone who has successfully bred it indoors. This article is intended to report the way in which I succeeded with this venture.

The Jacarini male in color resembles the Combassou superficially. He is shining black all over his body except for white spots on the butt of the wing. In my experience, most males never quite complete the molt, and continue to have a few brown feathers here and there on the breast. His beak is black and considerably more pointed than the Combassou beak. The female is an assortment of brown shades, with striped breast.

I have in my home a tropical garden about 12 feet by 15 feet which is heavily planted mostly in pots, but with a few areas of large planters built into the floor and wall. In the room at the time of the successful breeding were a number of other species, as follows: A trio of Parrot-billed Seedeaters (Neorynchus peruviensis), a pair of Collared warbling Finches (Poospiza hispaniolensis), single Black-headed and Whiteheaded Nuns, and unidentified species of the Sierra Finch genus, breeding pairs of Diamond Doves and White Doves, and a pair of Button Quail. collection appeared to be quite peaceful and I pretty much left them on their own, going in only once a week to water the plants and merely stepping inside daily to leave fresh food. The southern wall consists of five 3' by B' glass panels, which raises the temperature too high when the strong winter sun hit it, and drops too much at hight when the coldness from the outside is conducted through the single-panel glass. (This was originally double thickness thermopane, but because of fungus between the oanels. I reduced them to single thickness class.)

The Jacarini is one of the most interesting birds I have known. When I lived in Peru, on numerous occasions I watched the male do his nuptial dance for over half an hour at a time, non-stop. He finds a bush about 40 inches high, selects a perch on top of it, flies straight into the air 30

or 40 inches, does a somersault and returns to his perch, singing all the time. He does not sit on the perch more than a few seconds before he repeats the performance. It goes on and on like a yo-yo contest. The female is usually not in evidence, although I assume that he knows that she is close enough to benefit from his amorous display.

The Peruvian name for the bird is "Saltapalito," which would be translated literally, "little-stick jump," but which probably would translate better as "oole vaulter."

I had just added the two pairs of doves to the collection, wanting to have my morning punctuated with the peaceful coo of these birds, so I constructed a dove nest tray about 10" by 6" and with a lio of one and one half inch furring strips, so that it was rather like a square bowl. I reasoned that when the doves saw this they would immediately prefer it to any other location (but I was wrong).

I placed the dove nest tray on the bottom hoops of a tomato rack, which held it up off the ground about 8", but left it quite in the open. I think the reason the doves never used it was the difficulty of landing with the wires from the tomato rack surrounding it. Two weeks later the doves had seemed to pay no attention to it but I noticed that the Jacarini male was coming into breeding color and that he was doing an occasional dance, so I took a large handful of grass shavings which I had saved from the summer, and in my haste, tossed them on the doves' nesting platform to keep the grass from the moist earth, thing that the Jacarinis would help themselves to the grass in order to build their nest. The amount I put on the doves' nest was generous, heaping and overflowing.

Much to my amazement, when I went in to feed a couple of days later, there was a beautiful, neat cavity indented into the mass of grass. It had obviously been tailored with meticulous care and was very delicately laid out in perfectly smooth symmetry. I could not be sure what bird had done it and had to wait for a couple of days until I caught the hen on the nest, which proved to be the Jacarini.

She laid two eggs that were a grayish green, with marked reddish spots scattered indiscriminately all over the egg. I discovered to my chagrin that the eggs are very brittle, when I broke two of them many months later in a subsequent nest.

Because the bird had built so close to the glass wall which stands between the family room and the atrium, I taped some poster board to the glass to reduce the interruptions that would occur whenever anyone came into the family room.

The hen did all of the setting. I never have seen the male anywhere near the nest. She apparently does all of the feeding, as well. Although I never saw her taking any live food at other times, while she was feeding the young she consumed a lot of meal worms. I also provide for those birds a simple egg food mixture which I have used for years, consisting of hardboiled egg and corn flake crumbs, the latter purchased in the supermarket already in crumb form. These two ingredients are mixed with about 20% crumbs to the mixture. The Jacarini consumed some of the egg mixture, but not a great deal.

She always laid only two eggs. I think by now I have probably had seven or eight sets of eggs, always two at a time. Dr. Lindsay Clack, who raised Jacarinis in Australia, tells me that this is the normal clutch with the birds that he has raided. Perhaps this is the reason why the male does not feed, or the result, because if only the mother is feeding, two gaping mouths are probably enough to keep filled.

The babies are tiny, fuzzy, light colored creatures when they hatch. When they were about a week old, they disappeared. Within a week there was a new clutch of eggs, and the process went on again. The second time, the babies disappeared at about the same age. I decided that it must be the Rufous-collared Sparrows that were the culorits, so I put in a trap that I had bought in Cuba many years ago, and caught them.

With the third nest everything went smoothly, the babies were banded at about ten days of age, and shortly after that they left the nest. The fourth nest worked equally well, almost like clock work. The fifth nest, which followed very quickly after the fourth, found me out of town on a trip and when I came back I banded the birds later than I had the others and this was mistake. I tried to put them back in the nest but they panicked and flew in two different directions, and I believe were abandoned by the hen.

As with the Parrot-billed Seedeaters, which I believe was a world first-breeding, concurrent to the Jacarinis, the Jacarinis went to nest on the Peruvian calendar. In Peru, the height of summer is January, and these birds nested in December, 1985. This article is being written in November, of 1986, and they have again constructed a nest in the same batch of grass. The reason for retaining the cycle may be due to the lighting.

They are excosed to four forty-watt Power Twist Vitalite tubes. These are on a timer which comes on at 6:00 a.m. and goes off at 5:00 p.m. I did it this way in order to get the birds onto a North American season, settling down for the night on a Hoosier sundown, which comes as late as 6:00 p.m. in July. That apparently has not happened, because the birds continued to breed on the Peruvian calendar, settling down to roost when the lights go out about 5:00 in the afternoon. I have chosen not to tamper with that lighting system. If it works, don't fix it, and since I've got these Peruvian birds breeding in November and December, why tamper?

It has been interesting to watch the Jacarinis come into breeding condition and follow through. This was done in an indoor garden. I hope someone is able to develop the skills to get them to nest in more confined quarters than that. It would be nice to have a strain of cage-breed Jacarinis.

BOARD MINUTES, DECEMBER 7, 1986

The December 7th Board of Directors meeting was held at the home of President Bill Parlee in East Hartford, Connecticut. The meeting came to order shortly after 2 p.m. In attendance were Nancy Reed, Tony Patterson, Brenda Geesey, Al Decoteau, Russ Armitage, Kelly Dahill, Jerry D'Agata, Roger D'Connell, Bill Parlee, and guests.

The Secretary's and Treasurer's reports were accepted as read.

COMMITTEE REPORTS

Membership Report - Russ Armitage stated that the Society was just short of the 500 membership mark and should top that figure by the end of December. He further stated that we have 36 affiliated clubs. As previously voted all membership services are now handled by Russ from his office at 345 Boston Road, Middletpwn, CT 06457.

Band Report - Roger O'Connell our new Band Secretary reported that there were very few 1986 bands left over and that the Society had made a small profit during 1986 on the band program. He further stated that considering the greatly increased demand for NFS bands that we are more than doubling our order for 1987 bands. Roger said that dozens of orders for 1987 bands had already been received and that all early orders would be mailed on December 26, 1987 which is the normal policy of NFS. Roger pointed out that members should anticipate their needs so that they don't run out of bands. Set your orders in early and allow 30 days for processing. The normal turn-around is less than 10 days.

The Publishing, Election, and By-Law committees had no reports.

Research and Standards - The different names for the NFS Breeding Program were discussed at length. Finchsave and Breeder Specialist were the two most interesting names discussed by the Board. The Committee discussed separating the Breeding program from Research and Standards and creating a separate committee to handle the program. Bill Parlee felt that the program would entail to great a work load on the present committee. All Decoteau announced that three subcommittees had been formed for our next three standards. Committees and Chairman are the Shafttail Committee, Brenda Geesey Chairman, the Java Rice Bird Committee, Dan Outz and Jon Hoffman, Chairmen, and the Diamond Sparrow Committee, Jerry D'Agata and Kelly Dahill Chairmen.

Promotion and Products - Kelly Dahill and Russ Armitage stated that the 1986 T-shirt program was a great success. They stated that there were only a few small and medium sized shirts left for sale. The module Zebra design was very popular and the committee felt that to continue with that same modern design would be advantageous. The Board discussed the species to be considered for the 1987 shirt. The Lady Gouldian was chosen.

Judges Panel Report - Al Decoteau stated that the Panel report would be a lengthy one and it was. He stated that at year end he gives his progress report of all the apprentices. Al did that, giving the name of each and every apprentice, what requirements had been completed and his suggestions on each one. The Board also was asked to vote on deleting certain apprentices and putting others on the inactive list. Some apprentices ask for a year off from the program which is acceptable.

Al stated that he felt two or three of the apprentices could complete the program in 1987 and could be brought up for the vote of the Board after the 1987 show season.

The Board gave its final approval on the appointment of Earl Courts to the Panel. Earl has completed all requirement of the program. The vote was unanimous.

The Board brought up the question of a judge that does not complete his paperwork and fulfill the requirements of the Panel Director. The judge involved had been contacted both by phone and letter regarding the complaints against him. All stated that at the time of this meeting those requirements had still not been met, and that this matter had occupied the time of the Board over the last four meetings (one year). The Board voted to remove this judge from the 1987 Panel of Judges. The vote on this matter was unanimpus.

Show report - The show report was given by Tony Patterson who stated that the show reports were coming in well this year. He stated that the only reports not received for show already held were the report of the Central Chio club and the Fresno report. He stated that there were still shows left on the schedule but that all reports should be in, in time to publish the points results for 1986 in the Jan/Feb issue of the Bulletin.

OLD BUSINESS

The Board voted unanimously to remove a judge from the panel.

The Board voted "FINCHSAVE" as the name to be used for NFS' finch and softbill breeding program

The Board voted to rename the Society the National Finch and Softbill Society.

The Board voted to accept the resignation of Nancy Reed as 2nd Vice President and accepted her offer to remain in the post until a replacement could be elected.

The Board voted to leave the geographic classification system intact.

NEW BUSINESS

The Board voted to nominate Brenda Geesey to fill the vacated unexpired term of 2nd Vice-President.

The Board voted to reorganize the upper management of the society so as to better administer the organization. This would create the positions of 3rd and 4th Vice-President and would realign job responsibilities.

The Board voted to activate the By-law committee to effect the needed amendments to change the societies name and to create new officerships.

The Board voted to drop the 3rd place plaque for all affiliated clubs to bring costs in line with affiliation fees.


The Board voted to offer a Softbill award package to interested clubs at additional cost.

The Board voted to drop the affiliated club name from the Rosettes in favor of the imprint: Awarded by "The National Finch and Softbill Society".

The Board voted to have two away Board Meetings per year. One to be held at the AFA Summer Convention and the other at the National Finch Society National Show (NCBS). This would place the winter and spring meetings in New England and the summer meeting in Seattle, with the fail meeting in Columbus, Ohio.

The meeting was adjourned after five and one-half hours at 7:30 p.m.

They are both males, I call them "Ranger and Tonto". I have always had a secret admiration for these pretty little singers. They do have the



BREEDING THE BLACK-CRESTED FINCH (lophospingus pusillus) bu Maxilla Evans

In 1984, my beautiful pair of Black-crested finches (also called Pygny Cardinals) lived peacefully in a 3' \times 5' \times 7' walk-in aviary. Their cage mates included Lady Gouldians, Cordon Bleus, Gold-breasteds, Red-eareds, and Drange-cheeked Finches. Whenever nesting would start I would find a broken egg on the floor. I thought this was an accident.

The Black-crested hen had constructed her nest in a canary nest pan placed high in the cage and concealed with artificial boxwood branches. She lined the nest neatly with the soft inner coat hair brushed from our Norwegian Elkhound. She sat closely —— I never saw her feed or drink —— for about two weeks and then began to carry egg food to the nest. The male showed much interest in the nesting, but did not participate, that I ever saw. In two weeks or less, I found a very immature baby on the floor and put it back in the nest, which contained no other eggs or babies.

The baby continued to show up on the floor, and even spent two nights cuddled under the Button Quail. Then I began to put it on the 2' high seed table in the cage center. All this was a classic example of being too heloful: on the table I saw the male abuse and pluck the baby even as he fed it. On the floor, the baby's mother fed it, the quail warmed it, and the father had ignored it. The baby died, and the hen's further nesting efforts produced nothing. I later concluded that on of two Gold-breasted also died of abuse, although I did not see it. Still I did not realize why those occasional eggs kept appearing on the floor.

In 1985, the Black-crested finches were turned loose downstairs in the American Singer canary breeding room which was 7'x 15' in hopes that more space and absence of other free-flying birds would calm the male's aggression. Nesting sites are arranged up high. In the Fall, courtship behavior was observed, but no nest was built. Perhaps the short days of Fall, and artificially lengthened days beginning in December, suitable for American Singer breeding, disturbed the finches' natural breeding cycle. They are native to the Southern Meaisohere where seasons are the reverse of ours. Or perhaps, I failed to supply enough protein in their diet.

In August of 1986, the Black-cresteds were back upstairs and installed in a triple canary breeding cage 30° long. The hen at once built her nest and soon there was an egg — — on the floor. The males was banished. In the next two days, the hen laid two more fertile eggs, and hatched two young from them. By this time, she was permitting me to raise her gently with a wooden spoon to inspect the eggs and babies, which were hatched with startlingly black skin.

The day they left the nest, they were panic-struck and pushed through the canary cage bars, hiding around the room in cracks I never knew existed. So the cage had to be covered with involon net. Then they scrambled to hide beneath the wire floor. I thought my ingenuity had been taxed to the limit, but there was more to come. In less than two weeks, the hen was back working at the nest and neglecting the young. I read in an out-of-print English bird book that in the wild the male feeds the young for up to a month after the hen returns to her nest for the next clutch. So I cautiously put the father back into the cage, where he immediately mated with the hen, devoured meal worms, and fed them to the young. No plucking!

In a few days, I saw the first egg — — on the floor with a hole pecked in it. For three days I closed off the male and young each night form the nest site with a wire divider until the next two eggs were laid and removed each morning. After the third morning, when it was apparent there would be no more eggs, the hen and nest were closed off permanently with the solid partition in the right end of the cage.

The male fed the young well for three day; but on the morning of the fourth day, there were the tell-tale little gray feathers on the floor beneath the cage. As I watched, it became apparent that stuffing in meal worms and pulling out feather was his program.

The final solution was to have the male shut off in the left end of the tree-sectioned cage, the young in the center section with food, and me pulling the wire partition many times each day, permitting the male to feed the young and then hustling him back behind bars. After how long I don't know — but it was long — one morning the young hopped down to investigate the food dish, whereupon the male was permanently banished, and the babies were weamed.

The hen raided and fledged the two young in her second clutch, alone, and laid a third clutch of eggs which were removed, nest and all. Eggs and nest are preserved on the shelf, and, having proved that I can raise Black-crested finches, I expect never to do it again.

I gave the male to Ray Johnson (NFS panel judge, Georgia) and dreamed the other night that Ray oiled its feet, performed other conditioning and grooming techniques known only to show winners, and in 1987, the Black-crested and Ray won "Best Finch" in the Big Show. Next morning, recalling the dream, I thought, "I can dream a better fantasy than that. I will take one of the babies, by ten grown into a neat and stylish adult with imposing crest, to the show, and the baby and I together will win the blue ribbon. Ray Johnson and the baby's father will have to settle for second place."

This last scenario is my fantasy revenge for the time that Ray was judging a finch division, and turned to the audience and said the Violet-eared was probably best, but because of dirty feet would place second. My Violet-eared waxhill.

HAL KOONTZ on Milk Feeding

HAL KOONT? ON MILK FEEDING

As you know I write this Australian finch column for NFS and ask on a regular basis that questions be sent me regarding Australian Finches. This month's column features one of these questions and my answers. If you have questions, write me a 2604 Auburn Court, Bakersfield, CA 93306.

Our milk feeding question comes from Tim Morris an NFS member from Rockford, Illinois.


MORRIS: In the March 1985 issue of the National Cockatiel Society Bulletin, Mr. Michael Underwood states in a letter to the editor; that milk is bad news for cockatiels. Ex: Milk passes undigested from the large to small intestine where bacteria try to digest it causing gas and diarrhea. He further states that it its not digested by the large intestine because there is no lactose enzyme.

The droppings from my Gouldians have always seemed loser than my other birds, but they have never really seemed to be in poor health. Last spring 1 had 20 infertile eggs though, with no hatchings.

KOONTZ: When I first began in birds I followed a canary breeder's approach to nutrition which included milk on wheat bread or Mocha mix on wheat bread. I fed this form approximately one year no adverse consequences observed. I do not feed milk to my birds now. I discontinued feeding it primarily because I was afraid of the milk souring and because it was too much work for me.

Powdered milk will not face the spoilage problem and I do not believe there should be a problem in feeding it. I know that experienced canary breeders in this country and finch breeders in England do feed milk on wheat bread to their birds. I have no knowledge about the digestion of milk in birds. All I can tell you is that experienced breeders have fed milk without visible adverse effects. It is also possible that milk has no positive effect on birds. I noticed no decline in my birds when I discontinued feeding milk and have successfully raised birds for years without feeding it. I am sorry I do not have more scientific knowledge so I could better answer your question.

MORRIS: I am very concerned with the problem of infertility. I really want to raise Gouldians. I have recently tried Orlux "Universal Softbill" diet, and my birds did not seem interested, so I discontinued using it after three weeks. Orlux was also very expensive for such results. I have offered mealworms, but nobody wants any since they have not had them in the past. I am not keeping Society finches right now, partly because I would like to let my birds raise their own young. Below is a drawing of the cages I am using. The one on the left houses 2 pairs of Bouldians and the cage to the right one with three canaries.



RITTER: I have recently stopped using the powdered milk portion of the diet and continued to offer fresh millet spray continually. Can you offer any advise?

KDONTZ: Regarding the egg fertility problem, I think the double breeder cage that you are using as two cages is too small for Gouldians. They need more than fifteen inches of length to stay in breeding condition.

The cage used a one cage (30 inches in length) should be all right. Souldians have a tendency to get fat when not made to exercise which can lead to sterility in the males. If they are not in good condition, I would put them in flights (say 8' long) until they got back in good condition. When I get infertile eggs, I generally blame the male. Determine whether he is getting too old to breed (5 years or older) or whether he is fat (yellowish instead of reddish abdomen under the feathers).

Incompatibility could also be a problem, especially if these birds bred with other mates before you bought them. I would try switching pairs around until I found a compatible pair. I would give each pair two or three months each time before switching mates again.

I hope this letter is of some assistance to you and that you are able to raise Gouldians in the future. They are truly one of the most beautiful finches on earth.

EDITOR'S NOTE: Veterinarian sources I have checked with see no problem in feeding milk to softbilled birds, as long as it, like fruit and greens, is in small amounts, as it can cause diarrhea. It is also an excellent source of calicum for egg production. I like Hal, however do not use it because of the bother and the spoilage problem. I increased my cage size by just 6" about 5 years ago and had better hatches with my Goulds.

NATIONAL FINCH AND SOFTBILL SOCIETY BYLAWS

Adopted by the Board of Directors on Sunday, March 15, 1987 and replaces those adopted on November 10, 1983 and September 8, 1985. These bylaws have been adopted subject to membership approval which is to be placed in the minutes of the next regular Board Meeting and subject to correction of spelling and typographical errors. These bylaws are on file with the Secretary of States office in Hartford, Connecticut.

ARTICLE 1 - NAME OF THE ORGANIZATION

This organization shall be known as the National Finch and Softbill Society, Inc. It shall also be known in a more casual manner as "NFS".

ARTICLE 3 - HOME OFFICE

The principle office of the society shall be 810 Silver Lane, East Hartford, CT 06118, or other address as the Board of Directors may from time to time select.

PARAGRAPH TWO.

<u>First Vice-President</u>: Shall fill the position of the President in absentia. Shall be first in succession to fill the position of the President should the President be unable to fill his term. The First Vice-President shall coordinate the activities of, and be responsible for, all Regional Vice-Presidents.

PARAGRAPH THREE.

<u>Second Vice-President:</u> Shall be second in line to the Presidency and first in line to succeed the First Vice-President.

The Second Vice President shall chair the Education Committee and coordinate the educational programs of the society. The Second Vice President shall also chair the Publishing Committee as well as sit on all Committees of the Society.

PARAGRAPH FOUR

<u>The Third Vice President</u> shall be in charge of "FINCHSAVE" the captive breeding program of the Society. He shall participate in the committee and guide the captains and breeders involved in the program.

PARAGRAPH FIVE

The Fourth Vice President must be a NFS Panel Judge as he/she shall serve as the Panel Director. The Fourth Vice President shall also chair the Research and Standards Committee and be in charge of Specie Classifications. He/she shall also be responsible for shows or exhibitions of the Society and member points arising therefrom.

PARAGRAPH TWO

Membership Committee: The Membership Committee shall conduct the membership affairs of the society, and shall from time to time conduct drives to increase the membership of the society. It shall promote the society at any event held nationally or locally in the Avicultural field unless such promotion should be contrary to the sponsoring organization's policy. The Membership Committee shall be chaired by the the Treasurer of the Society.

PARAGRAPH THREE

Show Committee: The Show Committee, chaired by the Fourth Vice-President shall be responsible for the annual show of the society. It shall be responsible for the day-to-day activities required to achieve said exhibition, and shall be immediately responsible to the Board of Directors.

PARAGRAPH FOUR

<u>Publishing Committee</u>: The Publishing Committee shall be responsible for all publications of this society. It shall produce and edit a bi-monthly bulletin for the membership of the society. It shall produce a Handbook or yearbook for the Society, and any other publications as directed by the Board of Directors.

PARAGRAPH SIX

Education Committee: This committee will assist its chairman, the Second Vice-President, in developing educational programs for the members of this society.

PARAGRAPH TEN

<u>Finchsave Committee</u>: The Finchsave Committee shall assist the Director of the program. It shall consist of members designated by the Director and the Board of Directors. This Committee shall help develop and preserve policy in regard to this captive breeding program. Only the Committee may request funds for the administration of the program. All funds used for the program must be authorized by the Board of Directors.

ARTICLE 14 - ARTICLES OF INCORPORATION

The bylaws hereby set forth in Articles 1 through 14 shall be considered the articles of incorporation of the National Finch and Softbill Society, Inc., and may not be changed in any way, subject to the terms of Article 13 paragraphs 1 through 4, as included herein.

Approval of Article ONE will mean your approval of the name change as is required in any other sentence of these bylaws. For the purposes of space any such other name change is not printed here in these proposed amendments.
