President's Message

In the infant years of NFSS, the Society was being inundated with letters from members requesting NFSS to assist them with buying babies or odd birds to complete pairs of finches and softbills. Attempting to respond to the members' needs, NFSS published the first NFSS Census results in the July/August 1987 NFSS Bulletin.

This voluntary bird census was then and continues to be a valuable tool to the finch and softbill breeder. The Census results published in *The NFSS Bulletin* not only enable the breeder to connect with other interested parties, but helps NFSS (including FINCHSAVE) identify species kept or hred in the United States. Members names, state, phone number and a listing of hirds kept and/or bred are published. Addresses are withheld in the best interest of the breeders. NFSS had the strong

desire to accommodate the breeder back in October 1984, when the first census information request was published, and has provided this valuable service to the breeders in every year but one since 1987.

The past Census' have provided information regarding babies available (BA) or not available (NA). It has been brought to our attention from various breeders that the status of availability is subject to change throughout the year and could become outdated quickly. Also, the symbol (NA) would possibly deter contact or communication between breeders. Thus, the Census Department has opted to omit the status of availability in the 1993-94 Census. Members need simply to contact each other for current status information.

The number of breeders participating in the Census has slowly increased over the years. In 1987, a mere 38 breeders responded. Over a seven year period NFSS has had a three-fold increase of respondents.

Greater diversity of bloodlines revealed

Our Census Chairman, Toni Rood submitted the following report on the 1993-94 Census. This year a total of 110 breeders responded from all over the U.S., Canada and Puerto Rico. He was very pleased to note that the compiled information indicated many breeders are working with several more pairs per specie

Just as there has been a need for this service in the past. NFSS has an ever increasing and dedicated need to continue to publish a complete Census to assist breeders in their conservation efforts, especially since the Wild Bird Conservation Act of 1992 has gone into effect.


... to your's!

Breeding the Australian Finches

The Owl Finch

Poephila bichenovii

Also known as Bicheno or Double barred finch breeders, we became more skilled at raising Owls.

I first became involved with the Owl finch when our club, Peninsula Caged Bird Society, decided to adopt this species and begin a breeding program for them. Fellow club member. Bea Rogers, and I acquired a total of five pairs between us. We took great pains to obtain birds from different sources so that at least some of the birds would not be related. Since neither of us had bred Owls before, we made a special effort to purchase some from a well recommended breeder. At first we were unable to raise chicks unless the eggs were fostered to Societies. As we gained more experience and exchanged information with other

As we gained more experience and exchanged information with other breeders, we became more skilled at raising Owls.

General behavior and requirements

The Owl finch tends to be highly active and nervous and therefore should be housed in a large cage (24"x36") or flight. Don't overcrowd as they can be aggressive towards each other and panic more easily under these conditions. I have found them to breed well both in a colony set-up and in cages, one pair per cage. With the colony set-up you have less control over mate selection and inbreeding is more likely to occur. I have better success using no more than two bonded pairs per cage, and even then they sometimes bicker over nesting sites. Owl finches prefer to sleep in a nest and providing one may prevent "night frights".

Owl finches are a highly social species and do not do well as single specimens. They have been known to pile into a single nest at night somewhat like Societies. Owls are described as fairly peaceful but I have found them to be aggressive towards their own kind when overcrowded and disruptive to other breeding birds in a mixed aviary. The disruption is due more to their high level of activity and curiosity.

Re observant! Because of their curiosity and activity level. I have found some Owls that have gotten themselves into potentially fatal situations. Two managed to slip into the top of a satellite hanging feeder I use. I now tape the sliding top shut. Another Owl wedged itself in between the tightly packed cedar branches and the mesh in a mesh bag (the kind onions come in) nest. In both instances I found the birds in time. So far none have caught their bands and all my birds are closed handed. This goes to show we must be alert to all potential hazards in their environment

Native Habitat

Area of distribution includes Northern and eastern Australia, Owl finches are often found near water sources and the landscape usually includes tall grasses, bushes and small trees. They frequently inhabit areas such as sugar cane fields, gardens and parks. Most of the Owl finches commonly available are the white rumped variety. In the Northern Territory and Groote Eylandt (one of the northern islands) is a nominate which is black rumped (P.B. annulosa).

Housing and environment

Minimum breeding cage for one pair should be 24" x 24". Sometimes two pairs can be bred in a 24" x 36" cage if they all get along well. Ideal setting is a planted flight cage indoors or outdoors depending on climate. Location of the cage or aviary should be in a relatively quiet area.

Owls will tolerate temperatures down to 50°F but should be kept considerably warmer when breeding to prevent egg binding. Like many Australian species they stop brooding the young after one week thus requiring a warm climate to ensure survival of chicks. Lighting should also be provided if they do not receive enough natural light. Perches of varying thickness or natural branches should be available.

Sexing

It is difficult for me to visually sex Owl finches. Bea is much better at it. Generally the males have bolder dark brown neck and chest bands and the white is much brighter on the face and chest. Also males are said to have whiter spots on the wings. Females lay eggs and males sing. At least I haven't found a female who sings although this occurs frequently with Waxbills. It is possible to identify males as they will tend to sing if separated from other Owl finches.

Diet

Provide a high quality finch seed mix as your basic diet. I had to try several brands until I found one that contained the right mixture of seed that the Owls preferred. They also tend to like half-ripe seed heads and millet sprays. Offer them a variety of leafy greens: kale, spinach, dandelion and chickweed, as well as other vegetables (fresh corn, grated carrots) and fruits.

Other additions to the diet should include cuttlebone, finely

ground boiled eggshell, digestible mineral grit, sprouted seed. Petamine or vitamin-mineral supplement, and a protein food. The protein can be in the form of egg food. CeDe mix. dried or live musca domestica, mealworms, fruit flies, aphids—whatever source is available and readily consumed. I offer egg food mix (home made) to my Owls daily and they consume most of it. Bea offers CeDe mix (sometimes she moistens it). Some of my Owls greedily devour mealworms and others won't touch them. It is possible to keep Owls in top condition without having to give them live food as long as they get some type of protein food.

Also remember that Owls tend to be ground feeders. Mine are always pecking and scratching at the bottom of the aviary.

Breeding

Owls can be difficult to breed as they are not as calm as Gouldians. However, once they settle down and are provided proper housing, diet and nesting facilities they can be quite prolific. I've gotten to the point where mine will raise their own but they are not exactly what I'd call prolific. Part of the problem is due to lack of space.

A breeding pair should be housed in a cage at least 24" x 24". You may be able to colony breed a limited number of pairs (2 or 3) in a large flight provided the pairs are bonded and you can closely observe the birds for proper record keeping. You can encourage a pair to bond by keeping them caged together, excluding all other Owl finches. After a

while they will start sitting together and preening each other. Once you feel they are strongly bonded you can put them with another bonded pair. Be careful that related offspring don't hond to each other. Owls mature at a surprisingly young age.


For cage breeding it is recommended that a binged top nest box be

mounted on the outside. Feeders and waterers should be mounted outside to allow more room and less disturbance during daily maintenance. The hinged top nest hox also allows for easy access to the eggs and chicks for egg transfers and banding.

Owls will also use a closed wicker nest and even a two liter plastic-bottle with a large opening stuffed with evergreen branches. Disposable cardboard nest boxes are convenient and cut the risk of disease and mites since they are not re-used.

Nesting materials usually consist of dried grasses and shredded burlap. It is interesting to note that in their native habitat, eastern populations of Owl finches line their nests with feathers whereas those in the north and northwestern areas do not. Both birds engage in nest building and both incuhate the eggs although the female usually spends more time in the nest.

Sometimes it is necessary to present live food in order to stimulate the Owls to breed. I have not been able to pinpoint a specific breeding season for Owls. They seem to breed all year long. They have also been found to nest at



different times in their natural habitat.

An open water dish is usually provided at all times for bathing. Not only because they love to bathe but breeders feel the moisture helps maintain proper humidity for the eggs. I have bad instances where unhatched eggs were found to be dried up when opened. As gross as it may sound, you should open eggs that have been long abandoned or gone at least a week past their hatching date. You can determine whether the eggs were fertile, if the chicks did in the shell, and whether there was sufficient moisture. Eggs usually have to be incubated one week to detect signs of fertility (presence of red blood vessels in yolk).

Fostering

Sometimes the birds just will not incubate or will destroy the eggs. In these instances it may he necessary to foster the eggs to Societies or Zebra finches. For the best results do not mix the Owl eggs or chicks with those of other species. You run the risk of lowering the Owl chick's chance for survival. Remove the Owl

chicks as soon as they are independent and place them with their own kind to prevent imprinting on the foster parents. Every once in a while I hear an owl sing a very strange Society-like song, not that Owls have what you would call a melodious song. Fostered birds can and do grow up to be successful parents.

Hatching and care of young

Owl chicks are smaller than society or Zebra chicks. They are fuzzy and light-skinned when first hatched but the skin color gradually darkens. The parent birds should have plenty of protein food to raise healthy chicks. The protein food should be well accepted by the parents before the chicks hatch.

Owl chicks should be banded at about 7 days old with an "A" size NFSS closed band. You will find that the parents will leave the nest for longer periods by this time so it should be less disturbing. The chicks' eyes should be just opened at this age.

The following is an example of how well my Owls have progressed in raising their own. As the weather began to get cooler I was forced to move my finches to warmer indoor cages. This particular hen had a chick in the nest that was just beginning to feather in (her other eggs did not hatch). Hoping against all odds. I placed the chick and nest in the indoor cage which was much smaller and crowded. I kept checking the nest but none of the Owls would go in and feed the chick. In desperation I attempted to hand feed the chick

but knew I could not continue this due to my work schedule. As a last resort I took the chick out of the nest and placed it on the floor of the cage hoping one of the Owls would take pity on it and feed it. The chick could not fly. It just sat in the corner looking pathetic. After a while I heard begging noises and noticed that someone was feeding the chick. I breather a sigh of relief. From then on the chick was well fed. Fortunately, it was feathered out enough to maintain its body heat while out of the nest.

Egg Food Recipe

I hard boiled egg

! teaspoon dry vitamin-mineral supplement (Prime, Vionate, Toppers, etc.)

1 tablespoon 90% soy protein (soy concentrate has less sodium that soy isolate)

Boil egg 15-20 minutes. Cool, then finely grate egg and add powdered ingredients. You can add more soy protein to get a dryer texture. You can also add scraped cuttlebone or crushed calcium tablets if extra calcium is needed. Do not add any oils.

The Mynah Birds Called Indian Hill

By Dr. Al Decoteau Groton, Massachusetts

As people talk to me at shows. seminars and fairs, it has occurred to me that the majority do not know the differences between the various so-called Indian Hill Mynahs.

Not all Hill Mynahs come from India. The main genera name is GRACULA—now one can see where the name grackle came.

Gracula religiosa intermedia, the Greater Hill Mynah, is the one we most often see. It is quite renowned for its talking ability. It is ten to twelve inches in length and must be differentiated from the Lesser Hill Mynah, Gracula religiosa indica. The Lesser is not as good a talker.

In the Greater, the yellow wattles are separated only by a very small area of black feathers behind the eyes: these wattles end on the nape in a broad hanging lobe. The Lesser has a narrower beak and its wattles extend from the nape to the crown in a very narrow line. The black patch of feathers below the eye is much wider than that seen in the Greater.

The Greater comes from Thailand to northern India to the Himilayas. The Lesser comes from South West India.

The very large Javan Hill Mynah will go 15 to 16 inches and comes from Sumatra and Malaysia. Its wattles are separated from a small area of bare skin below the eye. The Javan is an excellent talker. When you see a giant Javan, you'll know it. It is much larger than the Greater Hill Mynah.

To give you an idea as to their occurrence in the U.S., there were about 75,000 to 100,000 of the Greaters brought into the U.S. in the late 1980's, while less than 200 Javans were imported.

We occasionally see a single Javan: it would be nice to pair up these singles and attempt to breed this magnificant Mynah. Gracula religiosa religiosa.

Red-headed Weaver Clutch Hatched Under Societies

By Jim Cody Swannanoa, North Carolina

The well-known Cutthroat finch has a rarer, more beautiful cousin—Amadina erythrocephala, the Red-headed finch, sometimes known as the Aberdeen finch [or Paradise Sparrow. The male's head is a dull red. The breast is covered with scaly black and white markings on a fawn background. Females are barred in black. The hen has no red, and is mottled grey-brown.

Native to South Africa, north to Angola, it inhabits dry savannah and semi-arid regions.

[It] can become aggressive with smaller birds, especially when breeding, I bought two pairs from a quarantine station in November 1991. One hen was lost, The remaining hen promptly paired with a male and three weeks later began laying. They were in a flight with other finches of the same shipment.

The pair selected a half-fronted nest box and stuffed it with hay. Five large white eggs were laid, and incubated. Three were fertile and hatched. Whether they fed at all, I don't know but the young were thrown from the nest. The hen laid three eggs in a coconut and two in a wicker nest. These were put under two male Societies where four hatched. Because of their large size,

and coloration—all black—I was anxious about their success. All four were fed and left the nest at 22-24 days.

Three females left first and then, two days later, a male came out. He lived only four days. The young were very wild for about a week and I think he injured himself. After about a week the hens became nearly as tame as some of my cauaries.

After this round, my Cordon Bleu's were attempting to nest, so the Red-heads were removed from the flights and the hen put with the hen canaries, the two males were put with the male canaries. No aggression has been shown.

This is a beautiful finch which we should try to keep. It is very nest sensitive and will abandon it with the slightest provocation. It will cross readily with the Cutthroat but this is not recommended as we should keep the stocks pure.

My birds came from a quarautine station and a mouth later were as tame as canaries. I have enjoyed them greatly.

Conservation effort The Red Siskin Project

Habitat destruction and illegal trapping have devastated many species of birds. The American Federation of Aviculture (AFA) is a nonprofit conservation organization which seeks to preserve wild birds in their natural habitat and where appropriate, through captive breeding. The AFA's Red Siskin Project (RSP) is a model breeding program for endangered species of birds. It is run by private aviculturists, much like the NFSS FINCHSAVE program.

The Venezuelan Red Siskin is a beautiful little bird at 3 1/2" long; it is about the size of a Zebra Finch. The male is gorgeous with his black hood, black wings and tail, and red wing bar. Although red, his feather patterns resemble his cousins from North American. the American Goldfinch. Like the male Red Siskin. the female has black wings and tail and red wing bars but has an overall grey coloration.

The Red Siskin was chosen as the model bird for this breeding program because it is the only Red Siskin in the world. Most siskins have green and yellow patterns while some are black.

Since the early 1800's, the red Siskin has been trapped for the caged bird trade and shipped all over the world. By the late 1800's it was discovered that Red Siskin males could be hybridized with canary hens. All of the red canaries in aviculture to-day were derived from cross-breeding with the Red Siskins. Another factor leading to its demise were the skins/feathers to adorn ladies' hats. Both greatly reduced the wild Red Siskin population.

In the last 50 years the wild population has been reduced to two small fragmented groups. One in northwest Venezuela and the other in the north-central region. In the early 1980's, the late Sadie Coates, a field biologist, along with Professor Antonio Rivero, the world's most noted authority on wild Red Siskins, performed field studies to determine the remaining population of these birds. They found the wild isolated flocks to number between 600-800. At a 1993 meeting with Professor Rivero we learned it is very difficult to locate birds in the wild today.

Breeding in captivity

Because there are so few Red Siskins left in the wild, we do not wish to encourage their entrapment for our breeding purposes. Therefore, the RSP is working with Red Siskins that are currently found in aviculture. We will reintroduce captive bred Red Siskins back into their native Venezuela only if there is guaranteed protection from trapping. If this species becomes extinct in its native territories, then the captive population must be managed in captivity to prevent the complete extinction of the species.

We are applying for permits to import captive-bred Red Siskins from other countries, which are being donated to this cause. Because there has been so much hybridization within the Red Siskin captive popu-

lations, we are performing isoenzyme analysis to determine the extent of hybrids in our program, along with other countries' breeding programs.

If you are an independent breeder of Red Siskins, then the AFA-RSP would be willing to trade birds with you so that we both could benefit from

the exchange of bloodlines. We would also ask you if you could donate siskins to this program from your flock.

Milton was quoted as saying "Nature, she hath done her part, do thou but thine..." A successful project will show the U.S. Fish & Wildlife officials that we as private aviculturists can participate in conservation-oriented cooperative breeding programs. And if guaranteed protection is given, we can put hirds back into their native habitat. We have the collective expertise and the unlimited collective resources to really make a difference in the survival of endangered species of birds.

Member #43 reflects upon NFSS—The First Ten Years

Having just received my Jan/Feb 1994 issue of the NFSS Bulletin. I found an extra little letter from editor Martha Wigmore stapled inside. Martha's letter was sent a very small number of people who are still part of the first 200 NFSS members since its formation in 1984. She referred to us as "a very special group within NFSS." I had the pleasure of discussing this subject with Martha during a telephone conversation in early February. Now that's not what she called me when we talked! I think she said I was one of the original "Old ----'s" of NFSS. By the way, I've also seen that title printed on baseball caps in gag gift shops!

The purpose of Martha's letter to "a very special group within NFSS" was to remind us that 1994 is the 10th Anniversary of the National Finch and Softbill Society and we are "invited" to put a few of our thoughts on paper concerning the past 10 years. Actually, after thinking about it for awhile, it's quite an honor to be included in this group as I'm sure that names like Parlee, Decoteau, Geesey, Gunby. Clear, Hoppin, and others are also included. Way back in 1984. I was assigned NFSS membership #43 and I am proud to say that I still own this number today.

It's really hard to put my thoughts on paper concerning NFSS over the past 10 years. So much could be written! Rather than go through my stack of past NFSS Bulletins for ideas. I think I will just keep writing from memory and see where this article takes me (us).

Hooked on NFSS

I think my first recollection of actually being an NFSS member came at the first "Kaytee Great American Bird Show" in Chicago, Illinois (October 1986). It was at this show that I first met many of the original NFSS members on Martha's elite list. The 1986 Kaytee Show was also my first 'official" NFSS show as an exhibitor. I had shown finches for many years prior to the formation of the National Finch and Softbill Society, but your first NFSS affiliated show is always a memorable one.

Having read about names like Parlee, Decoteau. Hoppin, Gunby. Armitage, and Geesey in prior NFSS Bulletins, it was really exciting to actually meet and talk with these people. Dr. Al Decoteau was the NFSS Panel Judge for the Kaytee Show, and Bill Parlee was there as a mem-

ber of the overall Best in Show judging team. I remember arriving in Chicago expecting the largest and most competitive finch entry I'd ever experienced. Other than the 1984 Chicago National (not yet affiliated with NFSS). I had only exhibited my finches at local club shows. I remember sitting in the gallery watching every single

bird come in from of Dr. Decoteau. By the completion of the section judging, 1 had 2nd Best Society with a dilute crested and 2nd Best Australian with a white Shafttail, I could have gone home at that point very excited and very happy. However. following the Top Bench judging. Al had put my white Shafttail as 8th Best in Show. What a thrill it was to see a large pink NFSS rosette hanging from my show cage. I still have that rosette today! I know that Brenda probably had hirds on the Top Bench above 8th place, but her encouragement and excitement for my win will never be forgotten. I recall Cecil Gunhy's normal Shafttail taking Best in Show and I'll always remember Steve Hoppin's Pintailed Nonpareil as 2nd Best in Show. Needless to say. I left Chicago very excited and truly hooked on the National Finch and Softhill Society.

One of Martha's suggestions in her letter about writing an article for the NFSS' 10th Anniversary was something significant that NFSS has done. Responding to this idea could

fill volumes of NFSS Bulletins! My opinion on the significance of NFSS is that it put the finch hobby on the map and on equal ground with the other variety specialists. I don't know how it was in other parts of the country, hut in the section of the U.S. where I could participate, finches certainly played "second fiddle"

to canaries, budgies, and cockatiels. Since most other varieties of cage birds were already supported by specialists organizations, finch breeders and exhibitors were certainly in the minority. Ten years ago, the National Finch and Softbill Society started to change all of that.

Bypassing unaffiliated shows

I remember the first cage bird show I ever exhibited in had a total of *two* sections for finches and soft-hills. Zehras were shown in the zebra section and *all* other finches and softhills were shown in the A.O.V. section. That was it! There was no Best in Division or Top Bench judging, and the thought of a Best Unflighted finch was unheard of.

More on the Viduine Whydahs

I was very pleased to see the short article on Viduine Whydahs in the March/April issue. This genus has been largely neglected in aviculture. I would like to point out that there are at least three other species of parasitic Whydahs.

Baka Indigobird (Vidua larvaticola)

Masked Fire Finch (Lagonosticta

larvata)

Wilson's Indigobird (V. wilsoni)

Bar-breasted Firefinch (L. rufopicta)

Black-bellied Fire Finch (L. rara)

I am not sure whether any of these are currently found in aviculture. It is very hard to distinguish between the various species of Indigohirds. However, as they all imitate the song of their host species, aviculturists with a keen ear and host Fire Finches to compare to should be able to ensure that they have the correct host.

I would like to encourage others to try to breed these fascinating birds while there is still time. They can be successfully established in captivity. A viable captive-bred population of Pin-tailed Whydahs has been established in Australia even though there have been no imports since 1960.

The Wild Bird Conservation Act of 1992

The Impact of The Legislation

Proposed Regulations Under WBCA: published 3/17/94

The other night I had the rare pleasure of watching the Northern Lights for the first time. The river of light flowed directly overhead, from horizon to horizon, Its undulating currents and ripples made it seem as though the heavens had been reversed with the rivers from earth. It got me to wondering, as nature often does - wondering a great big metaphysical why?

I realized this morning that this delightful sense of why has visited me many times, and most often, though more subtly, when I'm watching our finches and softbills behaving in ways which are so natural to them, and so different than we humans. Our contact with nature actual physical involvement, not that which is filtered to us in words, photographs or on film, draws out of us the larger issues of life. Not such a bad thing, is it?

The other night 1 was also reading the Proposed Regulations under the Wild Bird Conservation Act (WBCA) published by the U.S. Fish and Wildlife Service (USFWS) in the Federal Register on March 17, 1994. You're right if you guessed that this was not nearly as pleasurable as watching the Northern Lights!

In hrief, the WBCA restricts who can import birds (see the Summary of Effects printed in the Mar-Apr '94 issue of The NFSS Bulletin) and what hirds can be imported, covered in part in this latest set of proposed regulations.

Some birds are classified as *Captive-Bred Species* under the proposed regulations, and importable with less hassle. The captive-bred list currently includes only 37 species of exotic birds (*see list*).

If a species is bred in captivity in large numbers, but individual birds of that species are still taken from the wild, that species cannot be included as a captive-bred species.

With a few exceptions which do not really impact finch and softbill fanciers, when a species is still taken from the wild, the species is classified by USFWS as a Non-Captive-Bred Species. Exporting countries must meet rigorous requirements before being granted approval to send non-captive-bred birds into the U.S.

When these regulations are finalized, and applications have been processed, the Service will publish a list of approved non-captive-bred species for import. It appears that gaining approval will be *very* difficult, and imports will remain fur some time at extremely low levels.

The proposed regulations also present criteria for qualifying foreign facilities that breed exotic birds in captivity. Captive-bred birds from qualified overseas facilities can be imported with much less difficulty. But at present, the few overseas breeding facilities which might be qualified would not be able to fill the import gap to a any significant degree.

All comments needed

The American Federation of Aviculture (AFA) proposes simpler requirements to qualify overseas breeding facilities and encourages aviculturists to send their comments to the USFWS. The AFA laments that earlier only 96 comments, including those sent by animal rights activists were received regarding proposed regs. AFA states "when you don't write. USFWS believes

you are not interested or do not care about the regulations!".

The USFWS is willing to answer any questions about the WBCA and regs. Mark Phillips with the Office of Management Authority working on the regulations, asked that callers *read* the regulations before calling. He stated that there are tremendous misconceptions about the regulations in the avicultural community, and we should understand that the Service is not out to get the cage bird community. But few of the aviculturists who have called, he added, have taken the time to read the regulations.

The comment period on much of the regulations discussed here ended MAY 16th (not April 16th as first published in the Federal Register). But comments on the requirements to determine importable non-captive-bred species may be received until JUNE 15th.

CONFORMATION (50 POINTS) (distributed as follows)

HEAD AND BODY: 20 POINTS The Pekin Robin should measure approximately five inches from the crown to the tail tip. The head should be nicely rounded, blending with a thick neck. There should be a slight dip between the head and the backline. The Pekin Robin should be a robust and full-bodied bird showing good substance. The eyes should be large and dark.

<u>WINGS: 15 POINTS</u> The wings should be held close against the body and the tips should meet evenly just above the base of the tail.

TAIL: 15 POINTS The Pekin Robin has a forked tail, the tips curving slightly outward. The tail is approximately two inches in length.

CONDITION (20 POINTS)

While the Pekin Robin is not extremely difficult to keep, excellent condition is expected on the show bench. All feathers should be present, clean and shiny and smooth. Legs and feet should be clean. Pin feathers, missing feathers, soiled or frayed feathers, missing toes or toenails are all condition faults.

COLOR AND MARKINGS (15 POINTS)

COCKS: The upper mandible must be red while the lower mandible must be a dull brownish black. Behind the beak is a pale pink area covering the lores drawing a sharp dividing line between a dark and light area over and behind the eye. The bead is a dark olive shading gradually into a greyish olive over most of the upper parts. The tip of the tail becomes blackish while the primary flight feathers are edged in bright yellow. Several fine lines of yellow show along the length of the flight feathers in contrast with lines of deep rust orange. A yellow throat patch under the chin fans down into a rusty orange. The underparts are a pale olive becoming very light in the abdomen, vent and undertail coverts.

<u>HENS:</u> There is very little difference between the sexes: hens have a paler yellow in the throat patch. In some cases, there is a duller orange on the wings.

DEPORTMENT AND PRESENTATION (15 POINTS)

<u>DEPORTMENT: 10 POINTS</u> The Pekin Robin should be very active in the cage moving back and forth. It should be extremely alert. Crouching on the perch is to be faulted.

<u>PRESENTATION: 5 POINTS</u> Perches should be firmly attached and of suitable size for the Pekin Robin. Show cage must be clean. As in all softbills, food and water must be in the cage.

News from Region 2: Southeast

The hig news from the Southeast region is the three breeding consortiums we have established in Central Florida. Suncoast Avian Society has Red-eared Waxbills and Fire Finches. The Central Florida Bird Breeders have the Bronzewinged Mannikin. The Greater Brandon Avian Society presently has Love Birds but have heen discussing various finch species with me.

Suncoast has registered their consortium with FINCHSAVE and I have given the paperwork to Central Florida Bird Breeders to register theirs. All three of these clubs have allocated the funds to buy the hirds in the consortium, then the birds are placed with various breeders in the club and set up for hreeding. The rules change a bit at this point for the different clubs. Suncoast splits the resulting off-spring with the breeder.

Suncoast is presently applying to have their consortium recognized hy the Florida Fish and Game. This is a prelude to recognition at the federal level.

All three of these cluhs have based their consortiums on a generic set of rules Dwight Greenberg of the Florida Federation of Avian Societies developed. He provided the basic paperwork to the different clubs for modification to fit their specific goals. Dwight has graciously offered his services to anyone in the country who desires to set up a consortium and needs a place to start. He can be reached by calling (407) 631-9800. Dwight is a very early riser so please no calls after 9:00pm EST.

In most areas of the country the bird show season is a fall event. The exception to this rule is the Florida State Fair Exotic Bird Show. This is a unique show in that each division is sponsored by a different bird club in Florida. The Gulf Coast Bird Club sponsored the Finch and Softbill division for a two day event held on 19 & 20 February. There were 127 Finches and Softhills on the 19th and 111 on the 20th, Earl Courts picked a Persa Touraco for Best in Show on the first day owned hy the Region 2 V.P. Dale Laird. Dr. Al Decoteau selected a Black Crested Finish for Best in Show on the second day owned by the NFSS President, Steve Hoppin.

NFSS 1st Qtr 1994 Board Meeting "By Mail" - 2/28/94

My sincere thanks to the seventeen of nineteen Board members who participated in the 1st Qtr 1994 Board Meeting "hy mail", especially those who took the time to add comments and suggestions.

The Board voted to approve

- a change from abbreviating the National Fineli and Softbill Society as "NFS" to "NFSS", and a change in the home office to that of editor, Martha Wigmore.
- a change in the club logo (see announcement of new logo contest elsewhere in this issue).

New NFSS Conservation Committee

The Board was asked to approve a grant of \$100.00 or less to help fund the Suncoasi Avian Society Captive Breeding Consortium. The Consortium was formed recently to work with Red-eared Waxbills and Fire Finches. They are a non-profit organization and are depending upon volunteers and donations to run the Consortium. They are a participant in FINCHSAVE. (In NFSS' fledgling years NFSS did make donations

to the American Federation of Aviculture.)

The Board voted to support the Consortium, but in response to the many good comments received regarding this issue, a new NFSS Conservation Committee has been formed to establish a budget, policy and procedures within NFSS for contributing to qualified programs. Before a grant can be made in this instance, NFSS must be financially secure for the year and rules need to be formalized.

The chairperson of this committee is Kris Kroner, and the members include Linda Oja, Steve Hoppin and 2nd V.P. Martha Wigmore. Any suggestions or ideas can be sent directly to Kris Kroner or any committee member (see page 8 for addresses).



The NFSS Apprentice Judge Program

As approved by the NFSS Board of Directors, November 1990

- 1. Any new apprentice is required to write a letter of request to the Panel Director, listing her/his qualifications.
- 2. Qualifications MUST include:
 - a. Have bred finches for five years.
 - b. Have exhibited under own name (or own aviary name) for three years.
 - c. Must have placed five (5) times in top ten is shows under (at least) three (3) NFSS Panel Judges.
- Must take and pass a written test with 90% or better. If not passed, must study for one year and take the test again (not within one year).
 The test to be taken only at: the Kaytee Great American or the National Cage Bird Show, by pre-arrangement only.
- Caunot apprentice until the test is passed. Each of three apprenticeships to be pre-approved by the Panel Chairman, the Panel Judge involved and the Show Manager of the show involved.
- Once three apprenticeships are completed and satisfactory reports are received from the judges involved, the apprentice must submit a request through the Panel Director for final Board approval.
- 6. The apprentice must appear before the Board (or submit a notarized statement) indicating she/he understands and agrees to the following:
 - a. When requested to write a report, it must be done immediately. (Example—the three reports of shows to be judged.)
 - b. All show reports must be in within two weeks.
 - c. All judges must respond to all inquiries and must participate on Standard committees.
 - d. NFSS Panel Judges must adhere to all NFSS Judges rules and must judge by current NFSS Standards.

The National Finch and Softbill Society's Finch and Softbill Show Classifications

Adopted by NFSS, 1988

A Committee has been formed this year to update the NFSS Classifications (see News and Notes this issue). The National Cage Bird Show will accept updated classifications from specialty clubs at its triennial review in 1995. Your input and suggestions are welcome at this time!

NFSS members and affiliated clubs should note that the Show Classifications as published in the 1992 Revision of *The NFSS Handbook* are not the most recently approved NFSS Classifications. The Classifications below, reprinted from the 1988 *Bulletin* with minor corrections, should be used by members and affiliated clubs as their guide for the 1994 show season.

For Exhibitors and Affiliated Clubs:

- All finch and softbill entries must be supplied by the exhibitors with appropriate food and water. Waterers are not to be removed from cages during judging.
- Local show officials must not allow the exhibition of federally or locally illegal entries.
