

Lowering the pH of the Drinking Water for Finches

Why would you want to lower the pH?

Many pathogens thrive under high pH conditions. Yeast, protozoa, and some bacterial issues may occur when heat or humidity is high or the immune system is suppressed (recently moved birds, during breeding season, during the molt, any stressful situation, etc.). Lowering the pH of the drinking water inhibits the ability of these pathogens to gain traction and affect your flock.

After years of research, I have discovered the best pH level to maintain healthy gut flora in Gouldians and other small finches is about 5.3-5.5.

When attempting to lower the pH of your water - whether it be to avoid yeast in a chick's crop, or to "sweeten the gut" and tighten droppings, you first want to TEST your water to see what the pH level currently is. I use aquarium test strips to do that here, though the aquarium department of your local pet store may have some better options, such as digital readout testers. The normal pH of your water will also depend on your water source and may vary greatly if you have a well.

My city tap water ranges from 7.0-7.2. At that level I need to add the following to lower the pH to 5.5:

- 1/4 tsp MegaMix (MM) per guart of water OR
- 1/4 tsp of Citric Acid crystals (CA) per quart of water OR
- 1/4 tsp Unpasteurized Apple Cider Vinegar (ACV) per quart of water (it MUST be unpasteurized to be effective) - OR
- 1/4 tsp KD Cleanser per quart of water

Once you test your water, you'll then add the appropriate amount of one of the above mentioned reducers to lower the pH.

When I test, I measure 2 cups of water and add 1/8th tsp of the lowering agent at a time, mix well, then RE-TEST to see how much the pH has changed. I continue adding by 1/8th tsp until I get pH the level I desire. I RECORD the amount I had to use for future reference. I typically test my water quarterly to be sure nothing has changed and I don't need to increase or decrease the amount of reducer I use.

The biggest issue is making sure there isn't so much that it totally changes the taste of the water. If you've had to add too much, the birds may not drink it - which would defeat the purpose. Watch for "squinty eyes". If you see the birds looking squinty, they aren't drinking enough and you need to reevaluate the amount of pH reducer you've used in their drinking water. Dehydration can quickly lead to death, especially in hot and/or humid climates.

I do NOT use CA, KD, ACV or MM every day of the week. I really only use it when I see a problem. I want my birds to become accustomed to regular, untreated water. I want them to be able to go to a buyer without having been "babied". They should be able to combat issues WITHOUT the use of a pH lowering agent, and should only need it on rare occasions. When I see an issue, I use one of these reducers as my first line of defense. Genetics, nutrition, overall health, stress level, and environment will all play a part in whether you see a need to lower the pH of your bird's drinking water, and how often.

I watch the droppings - when they become wetter than normal, I add the reducer. I also run environment swabs and fecal smears weekly to determine if pathogens are present.

You MUST know what normal droppings look like for YOUR species. Many times, dropping consistency will depend on what you are feeding them. If you are feeding fresh greens, chitted or sprouted seed, or wet soft food, their droppings will be wetter by default. If they are on a plain seed diet with nothing more than water supplements and grit, their droppings will be well-formed, relatively tight and dry. Birds who do not have a wet diet may have a small wet ring of urine around their droppings which is perfectly normal. If they are receiving supplements in their water, their urine and/or the urates may be slightly tinted yellow from the supplements. If you keep softbills, their droppings will be wetter by default, so knowing what's normal will be imperative to your husbandry regime.

Average Water Intake for Healthy Captive Birds

Over the last 10-17 years (depending on length of time any particular species was kept), I've tracked everything from seed hulls to water intake and have referenced the water intake for normal, healthy birds and multiple species. Average temperature in my bird room ranges from 65-72 degrees during the spring, summer & fall months, 48-68 during the winter. Humidity is always a bit on the high side right around 50-55%, but often much higher because my bird room is located in the basement. I will occasionally run a dehumidifier when the humidity is higher than 55%, but not often. I prefer to allow the birds to acclimate to their environment and build up immunities to issues that would be present during high humidity time. These totals are taken only from my own aviary and may be very different in other aviaries.

In my aviary, every species drinks a different amount of water. I track it daily and keep detailed for each cage. Birds in flights tend to drink less - no matter the species or mix of species – while pairs tend to drink more with or without chicks. Odd observation, yes, but a flock mentality does strange things to their eating & drinking habits!

Averages for species we currently keep or have kept are as follows:

- Gouldian ½ oz per bird per day
- Society ½oz per bird per day
- Chestnut Breasted Mannikin ½ oz to ¾ oz per bird per day
- Star Finch ¾ to 1 oz per bird per day
- Zebra Finch ¾ to 1 oz per bird per day
- Cherry Finch ½ oz per bird per day
- Shafttail Finch ¼ to ½ oz per bird per day
- Parson Finch ¾ to 1 oz per bird per day
- Masked Grassfinch ¼ to ½ oz per bird per day
- Blue Capped Cordon Bleu ¼ to ½ oz per bird per day
- Red Cheeked Cordon Bleu 1/4 to 1/2 oz per bird per day
- African Silverbill ¼ to ½ oz per bird per day
- Indian Silverbill ½ to ¾ oz per bird per day
- Owl Finch (Bicheno) 1/4 to 1/2 oz per bird per day
- Lavender Waxbill ¼ to ½ oz per bird per day
- Redbilled Fire Finch (Senegal) ¼ to ½ oz per bird per day
- Gold Breasted Waxbill 1/8 to 1/4 oz per bird per day
- Orange Cheeked Waxbill ¼ oz per bird per day
- Black & White Manikins 1/4 to 1/2 oz per bird per day
- Bronze Winged Manikins ¼ oz per bird per day
- Blue Faced Parrot Finch 1 to 2 oz per bird per day (they soften their food with the water and also try to bathe in the drinkers, so this could be less drinking and more mess making, there's no way to truly measure)
- Red Throated Parrot Finch ¾ to 1 oz per bird per day
- Quail Finch ¼ oz per bird per day
- Cutthroat ¼ to ½ oz per bird per day
- Spice Finch ¼ oz per bird per day

- Green Singers ½ to 1oz per bird per day
- Grey Singers ¼ to ½ oz per bird per day
- Cuban Melodious ½ to 1 oz per bird per day
- Weaver (Red Bishop) ½ to 1 oz per bird per day
- Strawberry 1/4 to 1/2 oz per bird per day
- Canary varies greatly from 1/4 oz to 2 oz per bird per day depending on variety and size
- Crimson Pileated Finch ¼ to ½ oz per bird per day. This small amount is mostly due to the wet foods they receive daily.
- Budgerigar varies greatly from ½ to 4 oz per bird per day mostly due to bathing in the water receptacle
- African Grey approximately 6 oz per day
- Orange Cheeked Conure approximately 4 oz per day
- Rosie Bourke 2 oz per bird per day
- Scarlet Breasted Grasskeet ½ to 1 oz per bird per day
- Canaries ½ oz per bird per day. Fairly consistent regardless of species (We've kept Glosters, American Singers, Fife and Rollers)

Taking into consideration that a medication or supplement may taste or smell bad, these amounts may vary greatly depending on what is added to the drinking water. Gouldians here, for example, will totally refuse to drink for up to 48 hours if they don't like the taste or smell. By then they are wobbly and looking dehydrated and squinty-eyed and will finally give in and drink, but in very small amounts averaging less than 1/4 oz. I have seen similar behavior in all of the species I've kept over the years, but to a lesser extent than with the Goulds.

These totals also change dramatically depending on the foods offered. Salt content and wet foods affect intake – changes in diet will also affect consumption, usually seeing it rise as much as 5x the norm until they've acclimated to the new diet, so obviously these totals may be very different from one aviary to the next. Overall health of the flock also plays a large role in consumption. In my experience ill birds, or those with mild issues, tend to drink more than those with strong immune systems and no outward signs of illness. And, of course, heat and humidity play a large role as well. A hot and humid aviary may see far larger consumption, while a drier, cooler aviary may see slightly lower consumption.

An important aspect of tracking water intake is observing whether a bird has received enough of a medication to actually stop an issue. In the past it has been a problem here and what prompted me to begin tracking intake. Unless I closely monitor their intake, I may not know for sure they are getting enough. When I do not monitor the water intake, my only other recourse is to check droppings and run crop washes (depending on the issue) to ensure treatment has worked. I perform follow-ups at 3 days, 7 days and 10 days following treatment, and monitor water intake the entire time. But all water is tracked daily, regardless of health in the flock.

The Benefits of Handling Your Birds Often

I know and understand that not everybody is a birdy Ninja like I am, and I also realize that not everyone is comfortable handling their birds. But I'd like to explain a few reasons why handling them is really imperative to a healthy flock!

But first, an explanation: I take liberties with my birds. I have never been one to "follow". When it comes to my birds, I always lead. I live outside the birdcage. My sole purpose in life while keeping birds is to disprove myths and prove theories. I ALWAYS question and never stop until I find the answer I'm looking for. How will I ever know the answer unless I take some risks and just TRY??? The answer to that question is I'll never know UNLESS I try. Therefore, I just do whatever I need to do to get that answer. You can't always worry about what another breeder will say. Sometimes you just have to live outside the birdcage and do it! Take that risk!

I've heard all the horror stories -

- "Don't touch the chicks, the parents will abandon."
- "Don't stick your hand in the cage unless absolutely necessary, it is too stressful for the birds."
- "Don't chase the birds with a net. 5 minutes of quick chase then some rest time is better than 10 minutes of chasing."
- "Don't touch the eggs, the oils in your hand will clog the pores of the egg shell and can cause the chick to die in the shell."

I say BAH to all of that! It's bunk. I've tested each and every one of these "myths" and have found them all to be untrue. I touch chicks, eggs, and parents multiple times throughout the day and they don't abandon. I always wash my hands before handling eggs because oiling WILL cause clogging of the pores on the eggs, but if your hands are relatively clean, there is no reason not to handle them if you need to. I chase my birds all over the place - usually all over the bird room. It's how I get my exercise! And when "I" get tired of chasing "them", I just stand still and wait for them to come to me - then I just snatch them out of the air with my bare hands. Learn how your birds move and you'll never have to fight to catch them again! Be one with the bird! Seriously gang. We need to lighten up!

Sure, if you have wild-caught birds that have rarely been in the hands of a human, chances are they will indeed stress out a bit. BUT, these little guys are MUCH stronger than most breeders give them credit for! You must get them used to you. The easiest way to do that is to get them from a chick and handle them often into adulthood. But if the birds are from another breeder and have never been handled, you need to be able to work with them in case of emergency!!! Take them in hand!

Handling your birds often will give you a good idea of their overall health -

One of the reasons I prefer Scatt over an in-the-water Ivermectin treatment (though I DO use both) is because it forces me to handle the birds regularly. Sure, I have a lot of birds and it can take me hours or even days to get through them all. But when I'm done, I have an excellent idea of not only who is healthy, but who may be coming down with something, who may be too fat, who may be too thin, who is beginning an early molt or even who is coming into condition when it wasn't expected. I know every feather, every eyelash, every weight of every bird in my aviary. I know instantly when taking them in hand whether or not they've gained or lost weight. I know if there are feathers missing, and/or if something just isn't right - merely because I handle them so often and know each and every one of them so well.

Handling them enables me to catch issues early. When I take a bird in hand for ANY reason, I always check them out from head to toe. I check eyes, nostrils, chest, belly, vent. I blow the feathers away from the belly and from up around the crop. I pull each wing out and check feathers and look for signs of mites. I weigh the bird and apply Scatt if they are due. I trim nails and beaks if necessary, and always kiss the top of their tiny birdy heads before releasing them back into their cage or flight because if they "smell" like anything, this is when I will most likely notice! A healthy bird should have no smell! They should NOT smell like ANYTHING. I make notes about each bird, recording anything I see that has changed from the last time I handled them. Yep, it's a lot of work, but it is well worth it in the end.

Handling them often also makes them less afraid of you for the times you MUST handle them. If you have an emergency in the bird room - a bird gets a leg caught in the cage bars, has a broken wing, had night frights and is injured, is egg bound, is bleeding, or any other issue that could possibly occur - you don't want the bird to drop dead in your hand just because you caught them! You need them to remain calm enough that you can handle them and attend to their injuries or needs. When you handle them often, they will be less stressed when you NEED to handle them.

Now here, my birds are in a constant state of change. I move cages regularly sometimes daily (yes, even during breeding season) - I walk through the bird room slowly, but with purpose. I don't whisper, I don't tip toe, I don't walk on egg shells. I act perfectly normal. I'll often have music playing quite loudly because I like to headbang to a little AC/DC while I'm cleaning cages (LOL - this is truth!). I run the shop vac daily, and sweep up under the cages several times per day. I reach into every single cage at LEAST once per day, but more often than not, several times per day. I'm wiping, chasing, checking nest boxes and/or chicks. I'm checking breeding adults for signs of lowered immune. I'm in there almost constantly throughout the day - all while multi-tasking on some other project or job.

When I bump up chicks with hand-feeding formula, I just reach into the cage and pull out the nest. If the parents are still in the nest, I open the lid and lift them off the chicks, then shoo them into the cage. It's like talking to someone without mincing words. You're telling it like it is. When I go into the bird room, I don't let the birds dictate to ME how I'll act, I dictate to THEM how THEY should act.

Mine are so tame many will come up to the cage bars and often kiss me. They sit close to me on a perch and sing their little hearts out. If I whistle their song to them, they whistle back. They hiss at me and even try to bite when I try to remove them from their eggs or chicks for the umpteenth time of the day, but they rarely ever freak out. Yes, they give me the "birdy evil eye", but they know I'm there to help. They know I'm there to take care of them, and they know when they need something all they need to do is ask. Yes, they "tell" me when they need something. If you pay attention to their body language, you'll see they may well be telling YOU something too!

If you are afraid, they will sense that. If you are clumsy handling them, they will respond in kind - but the more you practice, the less clumsy and more confident you'll become - and the less skittish your birds will become. Handling them takes practice, but practice makes perfect! It's really not that difficult if you only try. The more you do it, the easier it becomes!

SIDE NOTE: One of the things I will always remember because I was actually angered by it, was when someone posted a comment on one of my videos. They'd said that it was a shame I had used a dead bird to show how I do something. I was mortified! I sat and stared at that video long and hard to see if the bird ever moved - thankfully, it did SEVERAL times and was proof the bird was not dead, only very calm and quite comfortable in my hand. It never occurred to me that someone would think I'd use a dead bird in one of my educational videos. I was appalled they'd even suggest such a thing and told them as much! They were obviously one of those who never handles their birds and the birds freak out when they approach the cage. Mine just don't do that. That video was testament to how calm they really are.

Obviously you won't always get every bird to be that laid back and calm, but you can really get the bulk of your flock calm and settled with just a bit of attention daily.

Be one with the bird! Handle them often. Get to know them, and they'll get to know YOU!

2019 NFSS GENERAL ELECTION

All about NFSS Bird Bands & Show Services

Paula Hansen, NFSS Band Secretary

All NFSS band orders come with instructions and mailed First Class-USPS. Orders are checked for the membership. You must be an individual NFSS member. Anyone can order anything else listed on the NFSS Shop webpage.

All orders are mailed within 3 business days. You will receive tracking information within 3 days. Each band is sequentially numbered, band size, NFS and Year. All closed bands are registered in the NFSS Band Secretary's log.

Should you wish to loan your closed bands to other NFSS members email the NFSS Band Secretary directly with their full name, NFSS member number, band size and the band number sequence. Registered bands enables NFSS to contact you the breeder of a bird when we receive inquiries on lost/sold birds. I forward to you in email to make the connection. This is another service NFSS provides.

NFSS Bands are ordered 6 months in advance the year before, so the numbering is continuous throughout the current year for any given size. There are no custom engraving provided. This preorder we do is how NFSS keeps the cost to its member's affordable.

Closed bands remain on the bird for life. Normally applied to chicks at ages 6 or 8 days depending on the specie. NFSS has recommended sizes for closed bands. They appear in each journal and on the NFSS website.

All closed band orders for the New Year are held until Christmas week. PR & Canada do get mailed a few wks earlier due to length of mailing time. This is to ensure that breeders have bands just in time for early next year clutches. Make sure your PayPal account has the correct address and the postal service recognizes your name to that address or list care of (C/O) the resident's name living at that address.

Shop items:

- E-Z kits (small/medium/large) Kits come with tools and with preloaded rings. They
 are safer as they are closed not open ended, less snagging onto cage or nesting
 material, can place multiple rings on one leg and easy to roll off the birds leg. Do not
 use for budgies, any hook billed birds.
- E-Z Reload Rings: we carry extra reloads in 8 colors in the small popular size and 2 colors in the medium size. You can order 10, 25, or 50 rings in any combination. There's a size chart on the website.
- Ring Collector: This is a useful tool, hang up in a permanent place in your bird room, and never misplace entire strings of bands again. Organize all types of bands (Split Plastics, Closed Aluminum, or E-Z reloads by color).
- Band Cutter: This tool is the best tool we could locate, made in Europe. They are specially manufactured for removing bands from size A – M (2.1mm – 4.5mm). Great to have on hand for emergency removal.
- Band Cross Registration: This is overseen by our Judges Panel, Laura Tinker. This
 is for folks who order custom closed bands from clubs or other manufactures and
 wish to gain points. In order to accumulate points at shows for the bird it must be
 closed banded. NFSS Shows at your club, Regional Shows and at the National
 Shows. Visit our website for more information check our home website page.
- Affiliate Club Ribbons/Plaques: Lauren Ogburn has taken over the Affiliate Club department. We have forms to download or use on-line for clubs to affiliate each March, order show supplies any time. We have an electronic form for collecting your event information to post on our website and list in our Journal. Also an opportunity to be appointed NFSS Regional Show which entitles your club to a ½ page free ad. Assistance is available in creating your club ad if you don't have one.

NFSS Bylaws specify an election will be held every two years to elect the officers of the Society. All elected and appointed offices are open to current members. Serving on the NFSS Board of Directors is an honor, a responsibility, and a commitment of time in addition to the responsibilities of your office.

Board meetings are held four times yearly. Three are held online and the 4th quarter Board meeting will be conducted prior to the annual membership meeting held at the NCBS (it may be necessary to conclude the 4th quarter meeting online). Internet accessibility on a daily basis is necessary.

Elected officers should vote during the official meetings. Board members present annual budgets for consideration and are required to submit a detailed account of their expenditures and income to the treasurer on a monthly basis. In addition, officers must submit quarterly reports to the Board of Directors.

Knowledge of the NFSS Bylaws is essential and a basic understanding of Roberts Rules of Order is helpful. The board member's duty is to lead the organization in its mission and to keep it financially and legally viable. It is important that each candidate understand the responsibilities of the office.

Every person who intends to become a candidate for any office will be required to submit a bio/resumé to the chairman of the nominating committee stating their background and experience.

Time required: Four quarterly Board meetings are conducted, each lasting approximately a month, require a *minimum* of one hour daily to monitor and respond to posts. Time is also required to perform the duties of the office.

PRESIDENT

Preside over all meetings; attend to the day-to-day operations of the Society; be available to members of the Board, and also monitor NFSS Forums.

1ST VICE PRESIDENT (REGIONAL VICE PRESIDENTS, EDUCATION)

Work closely with the President. First in succession to fill the position of President in absentia or if the President is unable to fill his/her term; will coordinate activities and be responsible for Regional Vice Presidents, and approve checks made payable to the President.

2ND VICE PRESIDENT (PUBLICATIONS)

Second in succession to fill the position of President. Responsible for all NFSS publications; supervises NFSS WebMaster and Journal Editor. Available to the Editor and Advertising Manager for guidance in securing articles and ads; assists in obtaining competitive printing prices.

3RD VICE PRESIDENT (FSS AND CENSUS)

Oversee day-to-day operations of the National Finch/Softbill Save (FSS) program; work closely with FSS Committee, Group Managers, and Species Captains to develop species profiles; collect data, maintain records; coordinate activities of NFSS Captive Breeding Program; compile and publish a yearly census.

4th VICE PRESIDENT (Judges Panel/Standards/Research)

Must be be NFSS Panel Judge, serves as Judges Panel Director, chairs the Research and Standards Committee, and in charge of Species Classifications. Maintains records/points earned by members and birds from NFSS shows. Represents the NFSS as liaison with the National Cage Bird Show Board.

REGIONAL VICE PRESIDENTS

Responsible for encouraging membership and club affiliation in the Society within the region he/she resides. Responsible to the First Vice President and serves as part of the Education Committee. Encouraged to attend the Regional Show in their region, and hold at least one membership meeting annually within their region. They should always be a visible NFSS representative.

TREASURER

Must have business experience and accounting skills. Deposits/transfers funds electronically into and from various accounts will maintain up-to-date records, request budgets from all departments, and prepare annual budget for NFSS. Also receives/deposits/documents weekly payments to the proper account and provides the President with a weekly report. Requests approval for expenditures prior to payment. Prepare and submit to the Board at the 4th Quarter Board meeting a budget to be approved by the Board. Responsible for establishing and maintaining NFSS financial accounts and filing tax returns. An audit of the prior years financial records shall be performed by 2 BOD members not to include the current Treasurer each year and at any time the Treasurer is relieved of responsibilities.

EXECUTIVE SECRETARY

Must have good verbal and written communication skills, experience with using word-processing software and the internet. Takes minutes during all Board meetings, compile the minutes, and submit to the Board for approval. Maintains an archive of all minutes and the Society's official documents, and assist other Board members with correspondence as necessary.

MEMBERSHIP DIRECTOR

Responsible for receipt of and processing of new/renewal memberships. Maintains current membership rolls, making them available to Department Managers.. Documents checks and sends to treasurer, sends membership materials to new/renewal members, Must be familiar with Excel and able to monitor his/her computer on a daily basis.

BAND SECRETARY

Responsible for ordering and issuing NFSS bands, verifying membership satus for purchases. Submits monthly itemized expense/income report to the Treasurer. Requires computer knowledge, Excel, converting files to PDF, internet, and basic accounting skills. Negotiates purchases with band suppliers, working with foreign currency and verifying incoming merchandise.

AFFILIATE/AWARDS DIRECTOR

Responsible for club affiliations, selection of clubs hosting Regional Shows, and processing award orders. Submits monthly financial report along with any funds received to the Treasurer. Sends re-affiliation packets to clubs and when returned, enters all necessary information into a database. Forwards information to appropriate Department Managers. Information must be sent to the Membership Director for inclusion in the membership database. Also processes awards orders and maintains award inventory adequate for show season.

APPOINTED NFSS OFFICERS

The following officers are appointed via recommendation by the NFSS President & a majority vote of the BOD.

NFSS JOURNAL EDITOR

Basic grammar, spelling, computer, Excel, and publishing programs necessary, as well as knowledge of file types and how to utilize or convert them for use in the Journal. Handles all activities related to production of the bi-monthly NFSS Journal, including procuring articles and photographs, maintain communication
