The Hinze Cage

If one is really serious about breeding waxbills, then it is essential to house one pair of birds to a cage. The only time cages are unnecessary is if one intends breeding some of the timid colony nesting species, such as most of the Estrilda species, the Goldbreast and the Avadavats, which reproduce extremely well in a free-flying birdroom.



For some considerable time I pondered over the best design of cage that would suit both waxbills AND keeper. I decided that the cage had to provide the birds with space enough in which to live contented lives - and not just to exist! - and it was essential that an ambience could be created that encouraged breeding; on top of this it also had to be practical. After constructing two early prototypes I finally settled on a cage which I believe fulfils all the

criteria I set myself.

My cage measures 1.17 metres (46 in) x 58.5 cm (23 in) x 58.5 cm (23 in) and, conscious of the fact that all birds need to feel safe from predators, I elected to construct it out of plywood and give it a solid back and sides - but birds also require plenty of light. With this in mind, and like most box-cages, my cage has a wire-mesh front, but it

differs from the norm in that it also has an all-wire roof instead of a solid one. The reason for this is that the "open" roof allows extra light, be it natural or emitted from full spectrum fluorescents that can be placed, preferably, from 2-4 feet overhead, depending on whether one uses a single or double fitment (full spectrum lighting placed directly on top of a cage, or lower than that recommended, can cause visual

and endocrine disturbance (Thrush, P.R. 2000. Light Right. Bird Talk, Vol. 18, No. 1, pp. 36-38.)). If one is considering using full spectrum lighting it is best to employ 'speciality full spectrum' rather than 'general full spectrum'. Such light is also beneficial to plants, and my cage allows for a pot-plant to be placed in either side of it.

2.5 cm (1 in) deep galvanized metal trays are used for ease of cleaning and these merely have

newspaper placed in them as a lining. I prefer to use galvanized metal trays over wood or hardboard ones as the former don't become sodden or buckled due to absorption of water from spillages, such as from the birds' bath. During cleaning operations I place a divider in a central slot, gently persuade the



birds into one side and then completely slide the divider in behind them. The empty side can now be cleaned thoroughly as, unlike conventional cages, the cage doors open fully. Once the compartment is cleaned I close the door, pull the slide back half-way and gently persuade the birds to enter the now

vacated side. Once they do the slide is inserted fully again and the whole procedure repeated. When cleaning is over I pull out the slide so that the birds have a full run again.


I always place a plant pot (usually containing a Boston fern, as it turns into a nice bushy plant) in the left-hand side of the cage and I only ever feed and water my birds in

the right-hand side. So as to prevent escapes when replacing food receptacles I designed a smaller door inside each large door. If the birds are timid they hide behind the pot-plant and soon come to realise that this side of the cage offers them a safe haven. If for some reason I should need to pull a tray out

quickly for cleaning but do not want to overly disturb them, such as at breeding time, the birds are prevented from escaping by a flap that allows the tray to be removed but keeps the birds inside. At breeding time, a nest-box, basket or nest-pan is placed behind the potplant (the birds' "safe" area). The birds are able to remain in "their" side while I daily replenish their food, having

come to realise that I only ever put my hand in the right-hand side.

The beauty of these cages is that they can be housed one on top of the other, or side by side. They allow me to keep numerous different species or those of the same kind all in the same room, and all are protected from interference or





aggression from other birds. Waxbills are currently being housed in the cages outlined and all are looking immaculate and thoroughly content. In essence, I have been able to create miniature planted aviaries - as opposed to the stark, unappealing boxes with wire fronts that are frequently sold as bird homes. I have yet to

find a waxbill or finch that doesn't quickly settle down and enjoy life in my cages, which enable the occupants' characters to be displayed to the full.

In North America all-wire cages seem to be quite fashionable and much success with breeding waxbills and other estrildids has been achieved. However, some breedings have necessitated a light cloth being draped over the top and sides of these cages for extra privacy, which makes me feel that my type of cage is better. It is up to the individual to decide whether or not to paint them. If painting is selected they are best done in a light gloss paint, such as eggshell blue. A primer and an undercoat will be required before applying the gloss, otherwise it will just soak into the wood.

When deciding on the type of wire to use for box-cages or flights it is important to cater for the smallest species, even if one has designs on keeping larger ones. So often keepers chop and change and, therefore, it is as well to keep the cages uniform and not regret matters later. 1.2 cm (½ in) by 1.2 cm (½ in) wire



is preferable because the likes of Goldbreasts, and particularly their young, have been known to squeeze through anything larger. Green PVC-coated Twilweld is excellent and has the added advantage of being maintenance-free and, being dark, the occupants are clearly seen. Plain wire obscures a bird's image and having to paint it black is an unnecessary chore.

2.5 cm (1 in) deep metal trays are to be preferred over wood or hardboard ones as the former don't become sodden or buckled due to absorption of water from spillages, such as from the birds' bath. Hinged front lids should cover the entrance for the trays to prevent birds escaping when the trays are removed, such as during cleaning operations. The trays need only to have old newspaper placed in them for ease of cleaning, although some breeders prefer to use sawdust.

Perches are usually made of doweling and the thickness is really dependent on the size of the feet of the birds one intends to keep. If doweling is to be used it should be of two thicknesses, in order for the birds' feet get ample exercise. The pieces of doweling should be placed at either end of the cage, so that the occupants have to fly rather than hop. Natural perching, however, is far more aesthetically pleasing. Perches will need to be checked regularly for any soiling and either be changed or cleaned thoroughly when it occurs. Dirty perches can cause serious foot problems, and also eye problems should the birds be inclined to rub their faces against them, which they all like to do at some time, such as to rid themselves of an itch.

All dishes containing food should be positioned near the centre back replenished daily. Dishes should be washed in warm, soapy water and, at least once a week, I like to leave them soaking in a bucket of hot water containing a few small drops of bleach for at least half an hour. One can never have enough dishes at one's disposal and a rota system usually comes into force, whereupon while some dishes are in use others are being cleaned or have been dried and stored.

Once the birdroom is completely set up and the birds installed it is important not to startle them, as they could easily injure themselves. To help prevent this it is important



of the cage and the water dish nearer to the centre front. This prevents them from being fouled from the perching bird and also reduces the likelihood of water splashes getting into the seed and vice versa. Even so, the utensils will still need to be checked daily.

There is no need to have separate drinking and bathing water as birds invariably drink from their baths. I only ever use one water receptacle and this is cleaned and for the birds to get used to one's presence and movements as quickly as possible. I always lightly knock on the birdroom door before entering, whereupon I give a few whistles and utter some familiar phrases such as "Good morning my little beauties, it's only me." It really is amazing how one's birds, including new additions, quickly come to recognise their owner and soon settle down under such due consideration.

Euro Societies

My previous contribution to this journal was a small piece about a dedicated bird keeper and friend - the late Bob Rittmann from New Jersey - and how he imported from Europe his "Euro Societies". Several USA fanciers received his stock after his death, and are busy learning about them and how they differ from the birds generally kept by American fanciers.

Having kept these Euro birds myself for around 12 years and knowing most of the US breeders who are keeping these birds at present, I thought a brief piece on them might assist, as soon you should find it becoming increasingly possible to obtain these birds. You will no doubt want to know as much as possible about them in order to keep and breed them successfully.

The Dutch call them Japanese Meeuween, and refer to them in English as Japanese Finches. I was told it actually translates as Japanese Seagull, but I have no knowledge if this is true or not, having no idea of Dutch myself. We in the UK use the name Bengalese Finches.

"Euro Societies" are extremely attractive birds - particularly the Black Brown - and given the opportunity to acquire them, the majority of fanciers would without doubt be only too happy to add them to their

bird room. I do wonder what it is about these birds that causes rumours and speculations about their origins from fanciers. It has long been such with the Society Finch and appears to be the same with these Euro birds, but they are no mystery. Documented accounts of their development are available to those who look or ask, and here is a



brief history of these birds and what occurred to make them different to what most fanciers think of as the Society Finch.

They are of Continental European origin, developed mainly in the Netherlands and Belgium, and much could be written about how, when and where. Of course I will willingly provide such information to interested fanciers, but let us for our purposes here "cut a long story short" and deal with the basics.

The development of the Self Coloured Society Finch in Europe in the middle to late 1950's by rigorous selection from the variegated birds of that time, began a remarkable resurgence in interest and many fanciers became interested in the development of these Self birds. They saw in them a bird that could be improved for exhibition purposes. The birds at that time still looked much like the wild ancestors of the Society Finch, Lonchura striata, variously called The Striated Munia, Sharp Tailed Munia or White Rumped Munia.

The solution undertaken to improve their colour was hybridisation with other Lonchura family members. Notably recorded as being used are, L. *maja*, the White Headed Nun, and L. *atricapilla*, the Black Headed Nun, as a steppingstone in achieving this goal.

From my own experience of breeding members of the Lonchura family, and some of my own breeding results with "Euro Societies", I believe these were not the only Lonchura to find their way into these birds, I think somewhere along the way the Black Mannikin, L. stygia and the Dusky Munia, L. fuscans, also played their part, but this is only speculation. I have no actual published proof. I read often in speculation that the Spice Finch. L.punctulata, was used in the process. This is probably because of the distinctive breast design seen on the Euro birds, but let me assure you this is definitely not the case. The Euro breast design bears little if any resemblance to that seen on L. punctulata.

This is how the Euro birds began their journey towards the bird we


see today, and after 50 years of development, the Euro Society is now finding a home and a following in the USA. If its progress across Europe is any indication of it's popularity with fanciers, it will not be long before it has found it's way into many bird rooms across the country.

Here in the UK, our traditional Self Coloured Exhibition birds have all but disappeared in the last 5 years to be replaced on the show bench by Euro type birds. We do not regard them as "Continental" birds now, although when they first appeared at shows, there was much controversy and argument over their eligibility to compete in our classes a situation I can imagine arising in the USA. But as they became more universally available, they gained acceptance and are now regarded as the "norm".

These birds are NOT Society Finches, and treating them as such will lead to disappointment for any fancier who thinks they are the same trusting and prolific birds they are used to keeping. Their behaviour is more like their hybrid ancestors. They are more Mannikin or Munia than Society Finch. The prolific Society Finch that will breed under most conditions and whose only purpose seems to be to fill the world with their offspring, is the bird for you if you want a quarantee of nest boxes full of youngsters. "Euro Societies" can be difficult to downright impossible in the breeding cage, but can be persuaded to breed with fair results. For the next issue of this Journal, I will put pen to paper in a further part to describe the husbandry required to breed "Euro Societies"

Breeding Yellow Bellied Tits (Parus *venustulus*)

The Yellow Bellied Tit comes from China. It measures four inches long.

They look very much like a Coal Tit (Parus ater). The cock has a glossy black head and throat, whereas the hen is light grey with moustache stripes instead of a black bib. Both sexes

I purchased my pair on 14-7-2000 from a bird dealer who had imported them from Belgium. They were in a sorry state - very dirty, with missing feathers, and unable to fly.

The weather was hot and sunny, but I didn't think they would survive in an outside avi-

ary. I hand washed both birds and put them in a cage with a lamp for warmth.

The following morning I put the pair in a 6ft x 3ft x 6ft aviary of their own. They had access to an indoor flight where food was put for them. During the winter months. I demolished aviaries and began to build new ones. They were all built of timber on brick bases with con-

crete floors. The largest aviary measures 9ft x 8ft x 7ft high. It is clad with ½" Twilweld mesh to deter mice. It is built between a shed and two Parrot aviaries, and has a Perspex roof and back to



have two white wing stripes and four white spots on the back.

Both birds, when moulted, lost the bright yellow underparts and looked very pale. allow as much light as possible. There is no shelter attached. The aviary is planted with Conifers, Hebes, Honeysuckle, Bamboo, and some flowering plants.

The pair were put in the aviary in March along with Rufous Bellied Niltavas and Pekin Robins. They have shown no aggression to any other birds. In the begin-



ning of April, two Tit boxes, 5" X 5" X 9" high, were put up both at five feet high. Both birds showed an interest, but nest building didn't start until the 22nd. Soft hay and Canary nesting material were used. Feathers and coconut fibre were offered but not touched. Neither bird had roosted in a box. Both birds slept in a conifer three feet off the ground - clearly visible from outside. They roosted outside all winter - even through a couple of nights when the temperature dropped to -10°c.

Food for the pair consisted of a good quality universal softbill mix, Ce-De parrot food, peanuts, sunflower seeds, and fruit, which was never eaten. The peanuts and sunflower had to be rationed as the birds buried and hid them all over the aviary. Mealworms were eaten, but waxmoth larvae and greenfly were favourites.

The pair now shared the aviary with a pair of Chinese Painted Quail and a cock Diamond Dove. The Niltavas and Pekin Robins were removed.

On the 24th of April, the first egg was laid, followed by three

more. The hen spent very little time in the box and when I looked in it, the eggs were covered up lightly with nesting material. A fifth egg was laid on the 30th, but the hen didn't incubate them. I removed the eggs, three of which were broken, on the 4th of June.

On the 6th of June, another egg was laid, followed by five more.

This time the hen settled down to incubate after the fourth egg was laid. The eggs are white with red spots and blotches mainly at the blunt end. They measure roughly 1.6 cm x 1.2 cm.

The first two eggs hatched early morning on the 22nd. Three hatched the following morning, and the last hatched on the 24th. On the 25th, the youngest chick had disappeared.

Chicks are born naked except for a small tuft of down on the





head and back. They are dark skinned and blind.

The chicks were fed on small maggots, which had been cleaned in a multi vitamin and calcium powder. Greenfly were also fed for the first two days.

For the first three days only the hen fed the chicks. The cock would enter the box only to have a look. He would only take food in if the hen were there to take it from him. The parents prepared waxmoths by removing the head and some of the insides. Some

and some of the insides. Some of it was eaten until it was the right size for feeding. Legs and wings were removed from flies and moths before feeding by the adult birds.

On the fifth day, both parents were feeding the chicks one parent waiting until the other left the box. After feeding the chicks, the parents would leave the box carrying a faecal sac. This was deposited on a perch by the cock or quite often eaten by the hen.

At five days old the chicks' eyes opened and feathers were seen forming on the wings.

The chicks were very vocal, calling every time a parent landed on the box. The birds were feeding mainly waxmoth larvae to the chicks. They ignored crickets, woodlice and earwigs. Mini mealworms were fed very rarely and maggots were now refused. Any insect flying into the aviary was chased and eaten.

At six days old the chicks are feathering up well and are being fed constantly by both parents. They are now being fed almost exclusively on waxmoth larvae. Everything except the occasional spider is ignored.

On the seventh night the hen roosted outside the nestbox on a perch at the top of the aviary.

The hen is so tame I have to be careful when feeding or entering the aviary as she hangs on the wire looking for food, which she readily takes from my fingers.

At nine days old, the youngest chick was found on the aviary



floor deed. It was much smaller than its nestmates.

At 14 days, the chicks were slmost ready to leave the box. The psrents were spending less time feeding them, but were constantly celling to them. The chicks would call to be fed when hungry, but were quiet for most of the day. More flies were being fed as well as wexmoth larvee.

On the 8th of July, two chicks fledged st 16 deys oid. I checked the nestbox ths following dsy end found two chicks dead. It seems the psrenta abandoned them.

At 18 days, the chicks spent most of the time sitting on the floor waiting to be fed. They ere dull coloured end resemble the hen. The hen was busy building a new nest in a half-open-fronted nestbox. She was csrrying grass into the box ell day, rerely feeding the chicks.

At 19 deys I removed a chick after noticing one of its eyes was shut. I cleened the eye with e week solution of TCP diluted In wster. I had to clesn it a number of times end it didn't open until the following day.

At 21 deys, the chick started pecking at food on the floor of its csge. By afternoon it was seting smsll amounts of Softbill food end wexmoth Isrvae that it dropped. It slso discovered drinking water. I was still feeding the

chick with waxmoth lervae snd soaked dog food. Its eye wes clearing up, too, end no longer nseded cleaning.

At 23 days the chick was esting enough food on its own, so i cut down on the feeds to a couple a day.

The two chicks were different to each other and besides being dullsr coloured than their parents, one resembled the hen with a small white pstch on the back of its head and the other's patch went further onto its back.

Without wexmoth Isrvae, maggots, ephids and later, flies, I would not have reared sny youngstere. The parents would only feed soft-bodied Insects. Both birds spent a great deel of time seerching the avlary for food for the chicks. Every leaf of every plant was examined, but very ilttle was found. Hopefully next year the plents will be more established and attract more insect life.

The hen built a new nest in s hslf-open-fronted box, then went back to the original nsst, end relined it.

She laid again on 17th July. The cock had siready begun to moult and showed no interest in another round.

The hen completed her clutch and then ebendoned them.

This article was also published in the British Cage and Aviary Birds Magazine and the Foreign Bird League and Foreign Bird Association Magazines. Mr. Sherlock was awarded a breeder's plaque for a first breeding by a Foreign Bird League member as well as Best Article of the Year.



A Visit to NFSS Region 3 Meet...

My beginnings in aviculture were simple ones. I was given three budgies and a cage. Our family always had animals when I was young, as my mother was an animal nut, but never birds. As I learned about those first birds. I found a place that sold all kinds of interesting supplies for birds including breeding style cages and the most important thing... more birds!!!! I added another budgle to create two pairs and in about a year those two pairs turned into twenty six birds. Then I added a parrot and went to work part time at the supply place. This all happened during 1982 through 1984.

In 1985 I moved to Florida to work for a friend managing a pet store. Once there for awhile I realized I was in bird addicts' heaven and started trying to decide what I liked better, parrots or softbills. It was a fun time in my "career" but there were times when I thought there should be a twelve step program for people like me.

I worked for the original pet store for about a year and then held several non pet related jobs. I then found a job with a pet supply distributor which was another truly fun job. I got to call on pet stores all over a specific territory every day and sell supplies to them. In my travels I found all sorts of interesting places to also look at and possibly acquire more birds. I found all the shows and marts to attend and met lots of other people that were involved with birds in one way or another. It was a great time in my life for sure.

In 1991 I met the man that would end up becoming my husband. The distributor I worked for carried Sun Seed as part of their offerings and the Sales Manager for Sun came to Florida to work with each of the sales representatives in the state. I had way too much fun working with him for a whole week and we staved in touch after he went home. After many ridiculous phone bills, I asked him to find me a house to rent in the area where he lived and I prepared to move back to a cold climate. Believe me, I tried to convince him to move to Florida but he would not and his job was better than mine so Ohio was where I was going. Brrrrr!!!!!! Now, I am familiar with winter weather since I grew up in Phildelphia PA, but it had been such a long time that I was not looking forward to it. Nor was I sure how I was going to move forty birds into such a different world. The challenge was on!!

In early September of 1992, Jeff called to say he had finally found a


house for me that allowed animals. Now the fun starts. I started looking into what type of trucks were available to rent and also started deciding just what I was going to take with me and what I needed to eliminate. I had lived on my own for a long time and had a house full of stuff along with the birds and a collection of tortoises and orchid plants. I also had a job to work at until the last possible minute. I sold all but one of my tortoises and gave away most of my plants. I found a truck through Ryder that had an access door from the cab into the cargo area so rented it for the trip. The birds in their cages would go into the truck first so that I could get to them from the truck cab for watering and general checking. I could also make sure that heat could get back there if it got cold on the way north.

Moving day was September 28, 1992. We could not have gotten one more thing in either vehicle if we tried. I had my full size pick up loaded to the point that there was just room enough for my small dog to ride on the seat beside me and Jeff had the big truck packed and the bigger dog rode with him.

We had our mini caravan and off we went. It took better than two days to get to Toledo and when we did I was instantly frozen. Florida was 96 degrees when we left and it was 40 in Ohio!!! The birds ended up staying one more day in the truck with a portable heater running for them while I got the house ready. We had to build stands to put the cages on in tiers since the room for the birds

was small but had very high ceilings. At this point I had small and medium parrots, one touraco and a pair of Lilac Breasted Rollers. It was a very full room to say the least but they all made it with no problems at all.

I lived in that house for one year then Jeff and I got married and we bought a house in Michigan right near the Ohio border. I still had the same birds and initially they were housed in the basement of the new house but it was a maintenance nightmare with low ceilings and no running water so we converted one half of the two car garage into a bird room complete with gas furnace and banks of lights. We put up a wall to divide the garage and insulated the whole thing and here I had my first true bird room. It was wonderful to say the least though taking



care of birds indoors is not exactly my idea of fun compared to housing them outdoors. They all seemed to take another change in stride and some went right to breeding. It was while in this house that I added a mate for my Touraco and also purchased a pair of Collared Warbling finches while visiting in Florida.

In the Spring of 1996, Jeff inher-


ited some money that enabled us to look for a home on a bigger piece of land and also closer to his office. The problem would be where to house the birds as I really wanted to be able to keep some of them outdoors during the summer months. We finally found the right house and decided to build a building just for the birds. (for those of you that are also members of the AFA, I wrote an article detailing

how we built the aviary building in the January 1998 issue of Watchbird)(it can be found in the archives of the Watchbird articles at AFA's web site).

It took almost a year to get everything done inside the new building



and there are some things I wish I had done differently but over all, it is a wonderful facility with more space than I ever expected to have for the birds I keep. I have expanded much further with softbills and finches and cut back on the number of parrots I keep. There is a row of indoor/outdoor flights for the hardier species I keep such as Red Billed Blue Magpies, Pied Crows and Green Hunting Cissa's. The softbills



all have walk in sized flights and the parrots that are still here have big 6 foot suspended cages. In addition to the species mentioned above, I also keep two species of Mynah (Indian Hill and Gold Crested), three species of Roller (Lilac Breasted, Blue

Belly and European), Plush Crested Jays, Western Grey Plantain Eaters (a touraco), Brazilian Cardinals, Oriental White Eyes, D'Amauds Barbets, Orange Bishop Weavers, Red Headed Finches, Violet Ears and a small group of Amazon Parrots along with Derbyans and some African parrot species. I also have Grey Peacock, Golden Pheasants and Bobwhite Quail.

Over all, I have enjoyed the years I have spent keeping birds and hope to continue for many more years. I am always interested in talking to others with similar species to compare methods and share ideas. Feel free to contact me via e.mail or phone, JanisClark@aol.com and 419-825-2839.

- A letter received from an attorney representing Mr. Scott concerning the publication of biographies in the NFSS Journal. An attorney, representing the NFSS, has sent a response. The issue has been resolved.
- Ginny Allen, Liaison Officer, announced that there are currently 51 clubs affiliated with the NFSS, and a lot of interest from people calling for affiliation/ membership information.
- Martie Lauster, Membership Director, announced that membership is up 20% over 2001. See her attached membership report.
- 4) Paula Hansen, Band Secretary, stated that the color of the 2003 NFSS bands is violet and that the first shipment is due to arrive during December 2002. The second shipment is due in February. Ms. Hansen stated that she is researching for best prices for the plastic split-bands.
- A discussion took place regarding the exceptional job that our webmaster, Harry Bryant, has done for the NFSS website.
- 6) Martha Wigmore, Director of the Judges' Panel, announced that the judges nominated for the 2003 National in Dallas/Ft. Worth are, in order of preference, Patrick Vance, Dale Laird and Armando Lee.
- 7) Ginny Allen announced the results of the election, held in November, 2002, to fill three Pro Tem positions: Band Secretary, Ms. Paula Hansen, Executive Secretary, Patrick Vance, and Region 8 Vice-President, Vince Moase.
- Bylaw Committee formed with Ginny Allen as chairperson. Other volunteers are Paula Hansen, Kerri McCoy and Julie Duimstra.
- 9) Patrick Vance appointed Chairman of the 2004/05 Election Committee. Darla Dandre has graciously offered to serve on the committee. Any members with questions regarding the election, nominating other members or themselves, please contact myself or Darla Dandre. A BIG thank you to Kerri McCoy for her assistance!

Motions voted on during the 4th Quarter Board meeting are as follows:

Motion 2002-19: Motion by Ginny Allen, seconded by Patrick Vance, that the NFSS offer incentives to advertisers in hopes of gaining future advertisers.

Passed: 9 YES, 2 NO

Motion 2002-20: Motion by Kerri McCoy, seconded by Patrick Vance, that Finchshop proceed with Sue Haberkorn's proposal to produce a "Finch/Softbill Cookbook". Passed: 10 YES, 1 NO

Motion 2002-21: Motion by Ginny Allen, seconded by Paula Hansen that the NFSS produce 5,000 flyers to be given to Carol Heesen, of Birds2Grow, who has agreed to send one to each finch person who places an order with her. Trial period to last for 6 months. Passed: 10 YES, 1 NO

Motion 2002-22: Motion by Ginny Allen, seconded by Patrick Vance, that there should be a review of the NFSS Bylaws whenever deemed necessary. Each officer would write a "job description". Passed: 8 YES, 0 NO

(See attached report from Ms. Allen regarding this motion.)

NOTE: Regarding motion 2002-22 (This was voted on at the NCBS, when we had a quorum which included the president)

Motion 2002-23: Motion by Kerri McCoy, seconded by Ginny Allen that the NFSS institute an award for exhibitors 16 years and younger.

Passed: 9 YES, 2 NO

Motion 2002-24: Motion by Kerri McCoy, seconded by Martie Lauster, that the NFSS secure an outside source to handle all NFSS election tallies.

Passed: 8 YES, 3 NO

Bylaws Review:

The NFSS Bylaws were reviewed and updated approximately 10 years ago. During the past 10 years, technology has reached a point where many members are now computer-oriented and on the internet. In fact, the present NFSS Board conducts its quarterly meetings on the internet. In addition we have an active NFSS Finch Forum with 200 members. Our www.NFSS.org website allows us, today, to renew, purchase memberships, shop at FinchShop and send forms electronically.

Our NFSS Bylaws need to reflect the acceptance of technology. Some wording may need to be changed.

Each board position, whether elected or appointed, needs to be clearly updated and defined so they include specific responsibilities. We need to list these either in the Bylaws themselves or as an addendum to the Bylaws.

We might want to consider creating new positions, combining some positions, eliminating others, and, in general, bring NFSS into the 21st Century.

An NFSS Bylaws review should begin immediately so the general membership is aware of the responsibilities of each office prior to the beginning of the 2003 election process.

Díd you know???

Do you know how far back in history incubation was a commercial activity?

According to A. F. Anderson Brown in <u>The Incubation Book</u>, page #158, Spur Publications, 1979, Incubators with a capacity of 90,000 eggs were in full production in Egypt at the time the pyramids were built. These Cameldung-fired incubators were responsible for ninety percent of the chickens hatched in Egypt as late as 1950. Temperature was monitored by touching an egg to the eye lid and humidity was adjusted up or down based on the sound of two eggs rolled together, which gave information about the size of the air cell.

Welcome to new NFSS Apprentice Judge

Laura Tinker of Holmes, New York is the newest NFSS member to meet the NFSS Apprentice Judge qualifications and pass the Apprentice Judge written test. Look for Laura on the show circuit in the coming months as she completes her apprentice judgeships with NFSS Panel Judges.

NFSS Judge selected for GABS 2003

NFSS is pleased to announce that NFSS Panel Judge Patrick Vance will be judging finches and softbills at the Great American Bird Show on October 4-5, 2003 at the Tinley Park Convention Center, Holiday Inn Select, Tinley Park, IL. See you there!

Band Sizes

A word on NFSS recommended band sizes: NFSS is fortunate to have access to a range of band sizes for our finches and softbills. A significant amount of testing by several experienced banding breeders went into the original NFSS band size chart, and modifications since have been done following additional careful research spurred by your recommendations.

Using the correct band size on the bird is important, first and foremost, for the bird's safety. Bands should have limited freeplay around the leg to minimize the risk of snagging on items in the bird's environment. To minimize the looseness of the band about the leg, NFSS recommends that one bands the bird while quite young, as nestlings - from 5 to 14 days depending on the variety - so that the band can readily slide over the "ankle" of the baby bird. As the bird matures, the growing "ankle" holds the band on and, with a correctly-sized band, the mature leg will neither be too snug or too loose in the band. NFSS band size recommendations are indicated for the banding of nestlings.

Safety is foremost. If you choose to band with bands larger than NFSS recommends (as some breeders do, such as those who band fledglings rather than nestlings) there is some greater risk to the bird by doing so. As a buyer of a bird you are best assured that the bird in question is the age shown on the band if the

band size indicates that the bird was banded as a nestling, per the NFSS recommended band size chart.

A word of clarification and correction on banding as it relates to NFSS exhibition awards. NFSS has a pretty nifty sliding scale of points for those exhibitors who enjoy this form of recognition of their efforts at our shows. More so than with any other avicultural organization, NFSS' points program provides, for most members, not competition, but recognition and no small degree of personal challenge and inspiration.

But ALL interested exhibitors may enter every NFSS show, NFSS member or not. In addition to your NFSS closed banded birds, your unbanded birds, your locally banded, and personally banded birds are all welcome, also. All birds entered are eligible for placement on the NFSS top bench - the top ten birds in show. If you are a NFSS member, you earn points for that placement as entry numbers and placement warrant. Your birds that are current year, closed banded (with bands obtained from any source) can be entered in NFSS young bird classes, and as such receive special evaluation and attention as "unflighted" birds during the judging, and are eligible for the NFSS Best Unflighted rosette at the show.

NFSS records points for individual

birds that are closed banded with NFSS bands. In addition, any finch or softbill wearing a closed traceable band issued by a national society other than NFSS can also qualify to earn NFSS points by registering the band with NFSS for a \$5.00 per band cross-registration fee. NFSS does not record points for birds banded with personallypurchased bands or locally issued. non-traceable bands. The NFSS band program provides its members a full range of readily available, safely-sized and traceable closed bands for finches and softbills, and this extraordinary service to its membership and their birds is supported by the NFSS Champion Bird program.

Please note: NFSS offers their band size guide as a "recommended guide" for members to select/purchase NFSS closed bands. NFSS does not have a policy in place that dictates birds have to wear NFSS "recommended size" closed bands in order to acquire points, but they must be NFSS or cross-registered bands to participate in the NFSS individual bird points program.

Exhibitors are everywhere!

The number of exhibitors at several of our clubs' shows this year was outstanding and holds great promise for our future!! 22 exhibitors at the Eastside Finch Connection show in Oregon, 19 at the Central Alabama

Avicultural Society show and 18 at our largest shows this year, the Puerto Rican shows! These areas report tons of fun and enthusiasm for the finch and softbill hobby – the NFSS members' attitude is catching on! Join in! Yes, it takes a bit of "oomph" to prepare and get your birds to a show, but it is the *best* kind of rewarding fun!

The only shows where there was a REAL problem attracting exhibitors were the two Midwest shows that go to all the trouble of organizing their NFSS shows and bringing in NFSS judges, yet insist on holding their shows on the same weekend as other. more established shows within the same area. This has gone on with these two clubs and the clubs they "compete" against year after year! How unfair this continued state of affairs is to the one and two exhibitors, respectively, who supported these poorly scheduled shows and to the others who are not given the chance to have their birds evaluated by another NFSS judge. NFSS members in the area, speak up! NFSS affiliates, change your dates work it out!! Give our hobby more of a chance in your areas!

Hop on Board!

As NFSS Judges Panel Director I receive the occasional call or e-mail from those who I'm afraid are still "missing the boat" when it comes to bird shows! How disturbing are the noisy few who don't hesitate to broadcast that they won't show until something-

or-another is nearer "perfect" and make something as delightful as showing finehes and softbills appear distasteful to newcomers. Newcomers, be aware! And please, go right ahead and get your birds entered into the next possible show! It's simple – and exhibiting birds has been a blessing for many, many finch and softbill hobbyists through the years! And bird showing is just plain fun!!

With the limited opportunities we have in our geographically-huge United States to actually see, let alone own and breed the many varieties of finches and softbills we enjoy, comes our responsibility to share our hobby and support fellow fanciers and our struggling local clubs maturely and compassionately. We are blessed with people in our hobby with infinitely varied backgrounds and interests. The rewards of sharing and exhibiting your birds whether bred, inherited or purchased - at NFSS' inspiring and educational shows are incredible. It's worth the commitment!

Don't be left on the dock!

"NFSS Exhibitors Extraordinaire"!

Remember last issue my reference to the tremendous accomplishments of many of our members, who I complimented with the invented term "Exhibitor Extraordinaire"? 2002 Exhibitor Awards

NFSS awards programs are one means of recognition of the effort and achievement of our exhibitors. Only those who have reached or come near the threshold for recognition of these exhibition awards can understand how much work and dedication goes into sharing their birds with us to this extent. Those in our hobby who thereby have so many opportunities to see finches and softbills at shows in our areas and across the country thank you all!

An exhibitor who accumulates 200 or more points during his or her lifetime achieves NFSS Exhibitor of Excellence status. The winner of the Exhibitor of Excellence award in 2002, accumulating 226 points to date, is Clarence Culwell.

Clarence's achievement has been accomplished over *many* years of NFSS exhibiting of his beautiful Zebra and Society finches.

An exhibitor achieves Champion Exhibitor status when he or she has accumulated 50 points or more during a calendar year. Achieving Champion Exhibitor in 2002 are:

Darla Dandre 58 points K.J. Brown 56 points

This is Darla's fifth straight year achieving Champion Exhibitor status, while K.J. Brown began this year as a Novice exhibitor. Thank you both for sharing so many truly magnificent birds with us at the shows!

2002 Individual Bird Points Records

If an exhibitor places in the top ten in a show judged by a NFS Panel Judge she will automatically receive the same number of points for the placement for her NFSS closed banded bird, per the NFSS Points Schedule. A bird can achieve **Champion Bird** status when it accumulates 50 NFSS points or more during its lifetime. Since 1984, 12 birds have accomplished this feat! At present, there are only two birds currently being shown with over 20 accumulated points. Both are exhibited and bred by Sally Huntington:

Pied Normal Zebra cock NFS D 2065 (00) 33 points Pekin Robin cock NFS J 8 (97) 25 points

Sally also bred and exhibited a beautiful White-eared Bulbul NFS K 164 (02) that earned 13 points in 2002, its first year! *Congratulations!*
